Anderson, P.; Miller; Swedzinski; Torkelson; Baker; Fabian; Lueck; Hamilton and Urdahl introduced:

H. F. No. 2280, A bill for an act relating to agriculture; appropriating money for compensation payments to commercial poultry producers.

The bill was read for the first time and referred to the Committee on Agriculture Finance.

Schomacker, Urdahl, Poppe, Swedzinski, Atkins and Lillie introduced:

H. F. No. 2281, A bill for an act relating to capital investment; authorizing housing infrastructure bonds to finance low-income senior housing; appropriating money; authorizing the sale and issuance of state bonds; amending Minnesota Statutes 2014, section 462A.37, subdivision 1, by adding a subdivision.

The bill was read for the first time and referred to the Committee on Job Growth and Energy Affordability Policy and Finance.
