For Minnesota's other 85 counties, CARES Act funding was available for less than 6 months, from July - December 2020.

³ Of the \$467 million in CARES Act funding distributed by the State of Minnesota to 85 counties, just over \$125 million or 26% was used for Small Business Assistance.

⁴ ARPA Local Fiscal Recovery Funds will be distributed in two tranches, the first in May 2021 and the second approximately 12 months later. Funds for eligible purposes may be used until December 31, 2024 (FY 2025).

Of this \$358 million, just over \$56 million or 15% was used by cities and towns for Small Business Assistance.

⁴ ARPA Local Fiscal Recovery Funds will be distributed in two tranches, the first in May -June 2021 and the second approximately 12 months later. Funds for eligible purposes may be used until December 31, 2024 (FY 2025).
