H. F. No. 1375, A bill for an act relating to real property; regulating causes of action arising out of construction defects in residential housing; providing for notice and opportunity to repair; proposing coding for new law as Minnesota Statutes, chapter 337A.

Reported the same back with the following amendments:

Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 2004, section 327A.02, is amended by adding a subdivision to read:

Subd. 4. **Response from vendor to notice of claim.** Following notice under section 327A.03, the vendee must allow an inspection and opportunity to offer to repair the known loss or damage. The inspection must be performed and any offer to repair must be made in writing to the vendee within 30 days of the vendor's receipt of the written notice required under section 327A.03, clause (a), alleging loss or damage. The applicable statute of limitations is tolled from the date the written notice provided by the vendee is postmarked, or if not sent through the mail, received by the vendor until the earliest of the following:

(1) the date the vendor gives written notice to the vendee of the vendor's offer to repair;

(2) rejection of the claim;

(3) failure by the vendor to make an offer to repair within the 30-day period described in this subdivision; or

(4) 180 days.

For purposes of this subdivision, "vendor" includes a home improvement contractor."

Delete the title and insert:

"A bill for an act relating to real property; statutory warranties; providing for notice and opportunity to repair with certain conditions; amending Minnesota Statutes 2004, section 327A.02, by adding a subdivision."

This section does not apply if the permit, license, or other approval is requested for the construction of a building or structure that cannot be built without physically moving the nonconforming use."

(4) engages in targeted residential picketing at the home or domicile of any surviving member of the deceased person's immediate family on the date of the service or ceremony.

(b) Whoever is convicted of a second or subsequent violation of paragraph (a) or a statute from another state in conformity with this statute is guilty of a gross misdemeanor."

"Section 1. **APPROPRIATION; PAYER OF LAST RESORT PAYMENTS FOR CERTAIN DUAL ELIGIBLE PHARMACY COSTS.**

The sums indicated in this section are appropriated from the general fund to the commissioner of human services to cover certain pharmacy and pharmacy-related cost-sharing costs for dual eligibles under the processes established under Executive Order No. 06-01.

\$4,000,000 is available to cover costs incurred from January 1, 2006, to March 8, 2006.

\$570,000 is available to cover costs incurred from March 9, 2006, to April 15, 2006.

The commissioner shall seek reimbursement for any expenditure made under this section. Any reimbursement received for payments under this section must be credited to the general fund.

**EFFECTIVE DATE.** This section is effective retroactively from January 1, 2006."
