"Subd. 12. Structurally substandard. (a) "Structurally substandard" means building code violations related exclusively to the building's:

(1) roof and roof framing elements;

(2) support walls, beams, and headers;

(3) foundation, footings, and subgrade conditions;

(4) light and ventilation;

(5) fire protection including egress;

(6) internal utilities, including electricity, gas, and water;

(7) flooring and flooring elements; and

(8) walls, insulation, and exterior envelope.

(b) A building is not structurally substandard if the estimated costs of satisfying the cited structural building code violations do not exceed 50 percent of the assessor's estimated market value for the building, as determined under section 273.11, for property taxes payable in the year in which the condemnation commenced."

"Subd. 4. **Redevelopment projects pending.** A taking of property is deemed to be acquired for mitigation of a blighted area within the meaning of section 117.025, and is not subject to the limitations under subdivisions 1 to 3, if the property is in an area (1) eligible to be certified as a tax increment financing district before August 1, 2006, (2) identified as in need of redevelopment in written reports that have been submitted to and reviewed by the governing body of the local government, (3) that has a third-party developer working with the local government on redevelopment, and (4) that has the support of a majority of the property owners in the area, as evidenced by a petition for completion of the redevelopment of the area by those owners submitted to the governing body of the local government by August 1, 2006."

"Sec. 7. [117.186] COMPENSATION FOR LOSS OF GOING CONCERN.

Subdivision 1. Definitions. For purposes of this section:

(1) "going concern" means the benefits that accrue to a business or trade as a result of its location, reputation for dependability, skill or quality, customer base, good will, or any other circumstances resulting in the probable retention of old or acquisition of new patronage; and

(2) "owner" has the meaning given in section 117.025 and includes a lessee who operates a business on real property that is the subject of an eminent domain proceeding.

Subd. 2. <u>Compensation.</u> In all eminent domain proceedings, the owner of a business or trade must be compensated for the loss of a going concern if the owner establishes that:

(1) the business or trade has been destroyed as a result of the taking;

(2) the loss cannot be reasonably prevented by relocating the business or trade in the same or a similar and reasonably suitable location as the property that was taken, or by taking steps and adopting procedures that a reasonably prudent person of a similar age and under similar conditions as the owner would take and adopt in preserving the going concern of the business or trade; and

(3) compensation for the loss of going concern will not be duplicated in the compensation otherwise awarded to the owner of the business or trade.

Subd. 3. **Procedure.** In all cases where an owner seeks compensation for loss of a going concern, the court must determine, upon motion by the owner, whether the going concern has been taken. If the court determines that there is a taking of the going concern, any damages must be determined by the court."

(2) address how the acquisition of the property interest serves one or more identified public uses or public purposes and why the acquisition of the property is needed to accomplish those purposes."

"Sec. 12. [117.226] FIRST RIGHT OF REFUSAL.

(a) If the governing body of the condemning authority determines that publicly owned property acquired under this chapter has not been used and is no longer needed for a public use, the authority must offer to sell the property to the owner from whom it was acquired, if the former owner can be located, at the original price determined by the condemnation process or the current fair market value of the property, whichever is lower.

(b) If the former owner cannot be located or declines to repurchase the property, the condemning authority shall prepare a certificate attesting to the same and record the certificate in the office of the county recorder or county registrar of titles, as appropriate, to evidence the termination of the right of first refusal.

Sec. 13. [117.58] INFORMATION ON OWNERS RIGHTS AND PROCEDURES.

The attorney general shall prepare and make available to the public a statement that summarizes the significant legal rights and obligations of condemning authorities, owners, and tenants. The statement shall describe the significant provisions of this chapter and any applicable federal law and provide an overview of the procedures and time frames involved in an eminent domain action. The statement shall include information for owners and tenants on where else they may get information on how to protect their interests in eminent domain. The attorney general shall revise the statement annually to ensure that it continues to describe accurately the statutory and case law governing the rights and obligations of condemning authorities, owners, and tenants."

<u>Subdivision 1.</u> <u>Authority to make offices appointive.</u> <u>Notwithstanding Minnesota Statutes, section 382.01,</u> upon adoption of a resolution by the Carver County Board of Commissioners, the offices of county auditor, county treasurer, and county recorder are not elective but must be filled by appointment by the county board as provided in the resolution.

Subd. 2. Board controls; may change as long as duties done. Upon adoption of a resolution by the Carver County Board of Commissioners and subject to subdivisions 3 and 4, the duties of the elected official required by statute, whose office is made appointive as authorized by this section, must be discharged by the Board of Commissioners of Carver County acting through a division head appointed by the board for that purpose. A reorganization, reallocation, delegation, or other administrative change or transfer does not diminish, prohibit, or avoid the discharge of duties required by statute.

<u>Subd. 3.</u> <u>Incumbents to complete term.</u> The person elected at the last general election to a position made appointive under this section must serve in that capacity and perform the duties, functions, and responsibilities required by statute until the completion of the term of office to which the person was elected or until a vacancy occurs in the office, whichever occurs earlier.

Subd. 4. **Publishing resolution; petition, referendum.** The county board may provide for the appointment of the county auditor, county treasurer, and the county recorder, as permitted in this section if the resolution to make the office appointive is approved by at least 80 percent of the members of the county board. Before the adoption of the resolution, the county board must publish a resolution notifying the public of its intent to consider adopting the option once each week for two consecutive weeks in the official publication of the county. Following the publication, the county board must provide an opportunity at its next regular meeting for public comment relating to the option, before formally adopting the option. The resolution may be implemented without the submission of the question to the voters of the county unless, within 30 days after the second publication of the resolution, a petition requesting a referendum, signed by at least ten percent of the voters registered in the last general election of the county, is filed with the county auditor. If a petition is filed, the resolution may be implemented unless disapproved by a majority of the voters of the county voting on the question at a regular or special election.

Subd. 5. Effective date; local approval. This section is effective the day after the governing body of Carver County and its chief clerical officer timely complete their compliance with Minnesota Statutes, section 645.021, subdivisions 2 and 3."
