## REPORTS OF STANDING COMMITTEES AND DIVISIONS

Becker-Finn from the Committee on Judiciary Finance and Civil Law to which was referred:

H. F. No. 1, A bill for an act relating to health; establishing a fundamental right to reproductive health; proposing coding for new law in Minnesota Statutes, chapter 145.

Reported the same back with the recommendation that the bill be re-referred to the Committee on State and Local Government Finance and Policy.

The report was adopted.

Hornstein from the Committee on Transportation Finance and Policy to which was referred:

H. F. No. 4, A bill for an act relating to transportation; modifying requirements for a noncompliant driver's license or Minnesota identification card and making related changes, including on eligibility, proof of lawful presence, primary and secondary documentation, and data practices; making technical changes; appropriating money; amending Minnesota Statutes 2022, sections 13.6905, by adding a subdivision; 171.04, subdivision 5; 171.06, subdivision 3, by adding subdivisions; 171.07, subdivisions 1, 3; 171.12, subdivisions 7a, 9, by adding a subdivision; repealing Minnesota Statutes 2022, section 171.015, subdivision 7.

Reported the same back with the following amendments:

Page 2, line 8, strike "is not eligible for" and insert "elects not to specify"

Page 3, after line 5, insert:

"(e) An application form must not provide for identification of (1) the accompanying documents used by an applicant to demonstrate identity, or (2) except as provided in paragraphs (b) and (c), the applicant's citizenship, immigration status, or lawful presence in the United States. The commissioner and a driver's license agent must not inquire about an applicant's citizenship, immigration status, or lawful presence in the United States, except as provided in paragraphs (b) and (c)."

Page 7, line 18, delete the new language and insert "(3) bear no indicator or design that relates to the lawful presence or the citizenship of the license holder"

Page 8, line 24, delete the new language and insert "(3) bear no indicator or design that relates to the lawful presence or the citizenship of the identification card holder"

Page 9, after line 4, insert:

"Sec. 9. **[171.1205] RESTRICTIONS ON USE.**

A state agency and a political subdivision must not use the possession of a noncompliant driver's license or identification card as (1) evidence of a person's citizenship or lawful presence in the United States, or (2) the primary basis for investigation, detention, or arrest."

Page 9, line 6, delete "\$.....in fiscal year 2023 is" and insert "\$1,453,000 in fiscal year 2024 and \$1,413,000 in fiscal year 2025 are" and delete "general fund" and insert "vehicle services operating account in the special revenue fund"

Page 9, line 7, delete everything after the period and insert "The base for the vehicle services activity is increased by \$891,000 in each of fiscal years 2026 and 2027."

Page 9, delete line 8

Renumber the sections in sequence

Correct the title numbers accordingly

With the recommendation that when so amended the bill be re-referred to the Committee on Judiciary Finance and Civil Law.
