**INTRODUCTION AND FIRST READING OF HOUSE BILLS**

The following House Files were introduced:

McDonald; Bliss; Nelson, N.; Jacob and Hudson introduced:

H. F. No. 5486, A bill for an act relating to commerce; requiring sellers to accept United States currency for purchases; proposing coding for new law in Minnesota Statutes, chapter 325F.

The bill was read for the first time and referred to the Committee on Commerce Finance and Policy.

McDonald introduced:

H. F. No. 5487, A bill for an act relating to education; modifying requirements to bring awareness of library services for blind and print disabled persons; amending Minnesota Statutes 2022, section 134.31, subdivision 6; Minnesota Statutes 2023 Supplement, section 134.31, subdivision 4a.

The bill was read for the first time and referred to the Committee on Education Policy.

Koegel and Hortman introduced:

H. F. No. 5488, A bill for an act relating to transit; establishing a pilot program for free transit service for certain students, educational staff, and attendees of athletic events; requiring a report; appropriating money.
