1.22 and for the purposes specified in this article. The appropriations are from the trunk highway
1.23 fund, or another named fund, and are available for the fiscal years indicated for each purpose.
1.24 Amounts for "Total Appropriation" and sums shown in the corresponding columns marked
1.25 "Appropriations by Fund" are summary only and do not have legal effect. Unless specified
1.26 otherwise, the amounts in fiscal year 2027 under "Appropriations by Fund" show the base
1.27 within the meaning of Minnesota Statutes, section 16A.11, subdivision 3, by fund. The
1.28 figures "2026" and "2027" used in this article mean that the appropriations listed under them
1.29 are available for the fiscal year ending June 30, 2026, or June 30, 2027, respectively. "Each
1.30 year" is each of fiscal years 2026 and 2027. "The biennium" is fiscal years 2026 and 2027.
