


MACHP (Minnesota Association of County Health Plans) is an alliance of CBP (County-Based Purchasing) health plans serving more than 84,000 members each month in **22 rural Minnesota counties**. Minnesota's CBP model empowers rural counties to exercise local decision-making, self-determination, and community-specific innovation in improving individual health, population health, and health equity, while reducing health care costs for their residents enrolled in MHCP (Minnesota Health Care Programs).



Itasca Medical Care

Headquartered in Grand Rapids and owned and governed by Itasca County. Serves over 9,100 MHCP participants.

PrimeWest Health

Headquartered in Alexandria and owned and governed by 24 counties. Serves over 47,000 MHCP participants. 11 more counties joined PrimeWest Health in 2020 seeking to bring CBP to their counties in 2023.

South Country Health Alliance

Headquartered in Owatonna and owned and governed by 8 counties. Serves nearly 29,000 MHCP participants.

THE STRENGTH OF CBP

Since 1982, CBP has provided locally responsive and locally accountable health care coverage to rural residents across Minnesota. Today, CBP organizations are ensuring quality, cost-effective care for more than 84,000 rural Minnesotans.

CBP ORGANIZATIONS:

- Improve individual health care experience, population health, and health equity, while controlling health care costs
- Coordinate with county services for more efficient and effective care
- Integrate with local social services, public health, behavioral health, medical care, and wellness programs to meet the unique needs of each Minnesota Health Care Programs participant
- Build strong provider relationships including enhanced reimbursements
- Partner with and improve access to local providers and local community resources
- Are governed by local county commissioners, providing local transparency and accountability
- Reinvest funds back into their local communities to strengthen rural health care
