Dear Governor Walz, Speaker Hortman, and Majority Leader Gazelka:

We write to express our strong support for establishing a Prescription Drug Affordability Commission in Minnesota this year. This bipartisan policy is being championed by legislators in the House and Senate and is expected to be a key recommendation from the Attorney General's Task Force on Lowering Pharmaceutical Drug Prices.

No matter where we live, what we look like, or how much money we have in our pockets, everyone gets sick. Illness reminds us that at our core, we're all human. But right now, people rationing life-saving medication are afraid for their lives. Minnesotans fear that getting sick will leave them bankrupt. Because our country hasn't enacted proper regulations, it's legal for corporations to price-gouge all of us selling medicine developed from publicly funded research. Life and health should not be for sale. Everybody deserves the best possible chance to live a healthy life, no exception. Drugs don't work if a person cannot afford them.

As drug prices continue to rise, the state has the legal authority and responsibility to take meaningful action.

The Prescription Drug Affordability Commission bill ([HF3228 Morrison/SF3120 Jensen](#)) would establish an independent Commission to evaluate drug prices and maximum reimbursement levels to protect patients, state and local governments, health plans, providers, and pharmacies from excessive costs. Affordability commissions are based on the precedent of health care rate setting and commonsense state regulation of public utilities.

The consequences of inaction impact every Minnesotan. When drug corporations raise the price of medicine without justification, it hurts everyone. It raises the price of health insurance premiums, harms the health, wellbeing, and livelihood of people who can't afford the medicine they need, and takes a toll on public health. For too many Minnesotans, drug prices are an issue of life and death.

Our government has the responsibility to address this crisis caused by pharmaceutical corporations. **Therefore, we collectively urge you to act this session by establishing a Prescription Drug Affordability**

**Commission in 2020. Together, we can enact a responsible, bipartisan solution rein in out of control drug prices that will have a positive impact on every Minnesotan.**
