1.2 (A13-0408), as follows:

1.3 Page 320, after line 20, insert:

1.4 "Sec. .... **MFIP CHILD WELL-BEING PILOT PROJECT.**

1.5 **Subdivision 1. Establishment.** The commissioner of human services shall  
1.6 establish and implement a pilot project in up to two counties to determine effective  
1.7 strategies to increase MFIP child well-being, especially to improve the school readiness  
1.8 of young children in families receiving MFIP by increasing their parents' knowledge  
1.9 of and access to information and opportunities for early childhood care and education.  
1.10 The commissioner shall develop the project in consultation with the commissioners of  
1.11 education, health, and the Housing Finance Agency.

1.12 **Subd. 2. Pilot project goals.** The goals of the pilot project are to:

1.13 (1) determine effective strategies to help parents identify when they or their child  
1.14 may benefit from mental health or early childhood services, understand the importance of  
1.15 obtaining services for themselves and their child, and know where to go for services;

1.16 (2) provide early childhood development information and resources to MFIP parents,  
1.17 including tools parents can use to track their child's development, resources used by other  
1.18 families in their communities to support their child's growth, and where to go if they have  
1.19 questions about their child's development;

1.20 (3) determine the best strategies to ensure that MFIP parents can attend to their  
1.21 child's development and potential need for additional services, if indicated;

1.22 (4) consider county staff training issues related to early childhood development  
1.23 and child well-being;

1.24 (5) test various methods of providing information about child development,  
1.25 including the impact of trauma and poverty in early childhood, to county staff, community  
1.26 provider staff, and MFIP parents; and

2.1 (6) maximize the use of existing resources.

2.2 Subd. 3. **County application; participation.** Counties may apply to the  
2.3 commissioner of human services to participate in the pilot project on the forms and  
2.4 according to the timelines established by the commissioner. The commissioner shall  
2.5 determine the county or counties, which must include at least one county that is not a  
2.6 metropolitan county, as defined in Minnesota Statutes, section 473.121, subdivision 4, that  
2.7 will participate in the pilot project based on the applications received by the commissioner.  
2.8 The commissioner shall provide technical assistance to participating counties, including  
2.9 advice regarding medical assistance reimbursement for certain screening and assessment  
2.10 activities under the child and teen check-up program.

2.11 Subd. 4. **Services.** (a) Services provided under the pilot project shall include, but  
2.12 are not limited to, providing parents access to:

2.13 (1) information regarding healthy child development;

2.14 (2) resources to support parenting; and

2.15 (3) specialized resources to prevent or mitigate developmental delays, including  
2.16 family home visiting, Part C Early Intervention, mental health services provided by a  
2.17 professional with training in children's mental health, child care, and Early Head Start  
2.18 or Head Start.

2.19 (b) Families must begin receiving services under the pilot project no later than  
2.20 July 1, 2014.

2.21 Subd. 5. **Parental participation.** The project must allow parents to count  
2.22 participation in approved early childhood programs as an approved MFIP work activity, if  
2.23 included in the caregiver's employment plan.

2.24 Subd. 6. **Report and recommendations.** The commissioner of human services  
2.25 shall report to the legislative committees with jurisdiction over health and human services  
2.26 policy and finance by January 15, 2017, information on pilot project participants,  
2.27 including information on child outcomes, children's school readiness, parent satisfaction,  
2.28 and parental ability to receive services or other information through the referrals provided  
2.29 by the county or other staff. The commissioner shall also provide recommendations to  
2.30 the legislative committees with jurisdiction over health and human services policy and  
2.31 finance to improve MFIP child well-being outcomes and to expand the project statewide  
2.32 if the results of the project indicate project participants achieved better outcomes. Child  
2.33 outcomes must be the primary factor for determining project effectiveness.
