1.6 (a) Individuals receiving services under a home and community-based waiver under
1.7 section 256B.092 or 256B.49 may receive services in the following settings:

1.8 (1) an individual's own home or family home and community-based settings that
1.9 comply with all requirements identified by the federal Centers for Medicare and Medicaid
1.10 Services in the Code of Federal Regulations, title 42, section 441.301(c), and with the
1.11 requirements of the federally approved transition plan and waiver plans for each home
1.12 and community-based services waiver; and

1.13 (2) a licensed adult foster care or child foster care setting of up to five people or
1.14 community residential setting of up to five people; and settings required by the Housing
1.15 Opportunities for Persons with AIDS Program.

1.16 (3) community living settings as defined in section 256B.49, subdivision 23, where
1.17 individuals with disabilities may reside in all of the units in a building of four or fewer units,
1.18 and who receive services under a home and community-based waiver occupy no more
1.19 than the greater of four or 25 percent of the units in a multifamily building of more than
1.20 four units, unless required by the Housing Opportunities for Persons with AIDS Program.

1.21 (b) The settings in paragraph (a) must not:

1.22 (1) be located in a building that is a publicly or privately operated facility that
1.23 provides institutional treatment or custodial care;

1.24 (2) be located in a building on the grounds of or adjacent to a public or private
