#### To Whom it May Concern:

I have had the opportunity to team teach a college welding course with an instructor from the North Dakota State College of Science in Wahpeton, ND during the 2018/2019 school year. I have seen firsthand the amazing opportunities available to our students just across the river.

Career and Technical Education (CTE) is very popular with our students. We do not have another college close to us where Breckenridge students can go to get CTE college courses. NDSCS is less than a ten minute drive away from our campus and they have amazing CTE courses, but at this time, our students cannot access them due to current laws.

In our high school, we offer a wide variety of CTE courses. We simply do not have the same resources in place like NDSCS has. During this school year, our students have been able to use state of the art welding equipment such as multi-process welders and a virtual welding unit that a high school just cannot afford. Having such a great resource so close and not being able to utilize it to its full potential just seems wrong. It is my hope that legislation can be passed allowing Breckenridge and NDSCS to partner and grow together providing amazing learning opportunities to our students.

Dear Legislators,

I am writing a letter of support for Bill SF 1938. Working in Economic Development for the City of Breckenridge and Wilkin County I understand the value of training a work force equipped with the skills the employers within our geographical region are desiring. The biggest issue that we hear from the local businesses is a lack of skilled workforce to fill the available positions in the region. According to the local job opening reports, there are more than 500 job openings with in 20 miles of Breckenridge. All the seniors graduating from High School in the same 20-mile radius still would not be able to fill all the job openings available in the area assuming we could place them immediately in the workforce.

Training our workforce needs in many of these skilled areas begins with a partnership with NDSCS. Geographically, it makes sense for Breckenridge High School to partner with a highly qualified college like NDSCS that can deliver top notch training we can't offer at Breckenridge High School and would be cost prohibitive to provide, all in less than a 10-minute bus ride.

To Whom It May Concern:

I am writing this letter in support of the partnership between Breckenridge Minnesota Public School and North Dakota State College of Science, which would allow Breckenridge juniors and seniors to take career and technical education classes on the NDSCS campus under an arrangement similar to PSEO with Minnesota institutions of higher education.

I am supportive of this innovative option for Breckenridge students for several reasons, including:

- 1) Safety and convenience for the Breckenridge students. The NDSCS campus is approximately only three miles from the Breckenridge High School. The nearest Minnesota institution of higher education with similar CTE programming is located approximately 50 miles to the north.
- 2) Relevant career and college skills training. NDSCS's mission is to educate and train a workforce with relevant skill sets necessary to fill the workforce needs in our region. Our College offers state-of-the-art facilities, equipment and highly-trained instructors in several CTE-focused programs. This partnership will provide Breckenridge students with hands-on experiences the school district is not financially equipped to provide.
- 3) Exposure to new career opportunities. This partnership will provide students with ways to explore career paths of interest and provide exposure to new career opportunities relevant to the agricultural and manufacturing backbone of Breckenridge and the surrounding area. Exposure to and exploration of our CTE programs will allow students to obtain the skill sets needed to open unlimited opportunities to become productive, long-term community members. These high school students are essential to the future of the local workforce and area economic development.

Founded in 1903, NDSCS is the second oldest two-year comprehensive college in the nation, with locations in Wahpeton and Fargo, N.D. The College offers a variety of face-to-face, distance education and online courses, as well as workforce training. NDSCS offers degrees, certificates and diplomas in more than 80 academic options in traditional career and technical studies as well as liberal arts. - With the beginning of the 2018-2019 school year, Breckenridge High School and NDSCS came together to form a partnership that would allow Breckenridge students to partake in a pilot program utilizing the NDSCS manufacturing curriculum, instructors, and facilities. Breckenridge students and parents had to pay a reduced rate of tuition to NDSCS in order to participate in this program while Breckenridge High School provided a certified instructor who transported and oversaw the students during a class period every day at the NDSCS campus.

#### Talking Points for a PSEO Agreement with NDSCS

- 1. This agreement is specific to ISD #846 students and NDSCS CTE programs.
- 2. This is a very specific and unique situation with a very narrow impact on State funding. Breckenridge and Wahpeton are the only border cities in which the Minnesota community does not have a post-secondary option and the border state community does.
- 3. NDSCS is less than 3 miles from Breckenridge High school. The next closest CTE post-secondary school is an hour away.
- 4. Breckenridge School Board members are in full support of this partnership.
- 5. Dr. Richman, President of NDSCS, and his staff are very interested in partnering with Breckenridge Schools. They are willing to be flexible with their time and resources within their capacity. NDSCS has proposed a fee structure per credit that would be well within the cost of PSEO CTE credits in MN post-secondary schools.
- 6. Breckenridge has aging facilities and outdated equipment no longer relevant to 21st Century Learning in our CTE shop areas.
- 7. Space is a limiting factor to expansion in Breckenridge for CTE programming, especially programs that require lab/shop space.
- 8. District size prevents us from offering a variety of electives in the CTE area.
- NDSCS has state-of-the-art equipment with a variety of offerings that would allow Breckenridge students to explore interest areas and exposure to new career opportunities we cannot offer in our small school setting.
- 10. The economic backbone of Breckenridge and our surrounding area is agriculture and the manufacturing that goes along with the ag industry. Students graduating with skill sets obtained in CTE programs have unlimited opportunities to stay in the Breckenridge community and surrounding area which is essential for the local workforce and area economic development.
- 11. With this partnership, we would be creating opportunities for students in careers important to our region: diesel mechanics, ranch management, H-Vac, plumbing, dental, nursing, small engines, auto, welding. This could create the next generation of workforce for CTE fields right in our backyard.
- 12. Recently our licensed agriculture teacher resigned to move closer to family near the metro area leaving Breckenridge without a licensed CTE ag teacher. We are in the process of recruiting a replacement for this ag position but at this time have no applicants. Licensed agriculture teachers are very difficult to find especially in our area. If we cannot find a teacher, these courses would have to be cut from our student offerings. A partnership with NDSCS would keep Breckenridge students from losing access to CTE classes in this content area. Again, agriculture is the predominant industry supporting the Breckenridge economy.
