1.13 Evidence-based literacy instruction is explicit, systematic, and includes phonological and
1.14 phonemic awareness, phonics and decoding, word study, spelling, fluency, vocabulary, oral
1.15 language, and comprehension that can be differentiated to meet the needs of individual
1.16 students. Evidence-based instruction does not include the three-cueing system, as defined
1.17 in subdivision 16.

2.14 Subdivision 1. **Literacy goal.** (a) The legislature seeks to have every child reading at
2.15 or above grade level every year, beginning in kindergarten, and to support multilingual
2.16 learners and students receiving special education services in achieving their individualized
2.17 reading goals in order to meet grade level proficiency. By the 2026-2027 school year,
2.18 districts must provide evidence-based reading instruction through a focus on student mastery
2.19 of the foundational reading skills of phonemic awareness, phonics, and fluency, as well as
2.20 the development of oral language, vocabulary, and reading comprehension skills. Students
2.21 must receive evidence-based instruction that is proven to effectively teach children to read,

3.19 Subd. 2. **Identification; report.** (a) ~~Twice per year,~~ Each school district must screen
 3.20 every student enrolled in kindergarten, grade 1, grade 2, and grade 3 using a screening tool
 3.21 approved by the Department of Education three times each school year: (1) within the first
 3.22 six weeks of the school year; (2) at midyear; and (3) within the last six weeks of the school
 3.23 year. Students enrolled in kindergarten, grade 1, grade 2, and grade 3, including multilingual
 3.24 learners and students receiving special education services, must be universally screened for
 3.25 mastery of foundational reading skills, including phonemic awareness, phonics, decoding,
 3.26 fluency, oral language, and for characteristics of dyslexia as measured by a screening tool
 3.27 approved by the Department of Education. The screening for characteristics of dyslexia

12.28 (b) Of the amount in paragraph (a), \$18,000,000 is for the Department of Education and
 12.29 the regional literacy networks and \$16,700,000 is for statewide training. The department
 12.30 must use the funding to develop a data collection system to collect and analyze the submission
 12.31 of the local literacy plans and student-level universal screening data; establish the regional

13.1 literacy networks as a partnership between the department and the Minnesota service
