1.5	Section 1. Minnesota Statutes 2022, section 477A.015, is amended to read:
1.6	477A.015 PAYMENT DATES.
1.7	(a) The commissioner of revenue shall <u>annually</u> make the payments of local government
1.8	aid to affected taxing authorities in two installments on July 20 and. Except as provided in
1.9	paragraph (b), the first installment of 50 percent of the payment is due on March 15 and the
1.10	second installment of 50 percent is due on December 26 annually.
1.11	(b) Notwithstanding paragraph (a), for aids payable in 2019 only, the commissioner of
1.12	revenue shall make payments of the aid payable under section 477A.013, subdivision 9, in
1.13	three installments as follows: (1) 14.6 percent of the aid shall be paid on June 15, 2019; (2)
1.14	35.4 percent of the aid shall be paid on July 20, 2019; and (3) 50 percent of the aid shall be
1.15	paid on December 26, 2019. For aid payments made pursuant to sections 6.91, 162.145,
1.16	477A.13, and 477A.15, the first installment of 50 percent of the payment is due on July 20
1.17	and the second installment of 50 percent is due on December 26.

1.19	suffered financial hardship due to a natural disaster, the commissioner of public safety shall
