Bill Description

House File 204 modifies the technology requirements for electronic voter rosters (also known as electronic pollbooks) to allow for the electronic capture of a signature. Current law requires that an electronic voter roster print the voter signature certificate and voter registration application, if applicable, and requires that a voter sign those printed documents. The changes in House File 204 would allow a voter to sign digitally, but maintains the requirement that a paper record be printed in addition to the electronic file.

Assumptions

Electronic voter rosters are purchased, certified, and maintained at the local level. There are no state programing IT costs associated with this change. There may be training and updates to elections administrator guides required, but as the Office of Secretary of State (OSS) updates training and guides on a regular basis, there will be no additional costs associated with this change.

As it relates to local costs, House File 204 is permissive, and does not require that a county capture electronic signatures. If a county chose to capture electronic signatures, the only vendor of electronic voter rosters currently deployed in Minnesota supports the capture of electronic signatures.
