Bill Description

The legislation amends the Eliminating Health Disparities Initiative (EHDI) grant program to add "prenatal care access and utilization" to the two existing priorities of decreasing racial and ethnic disparities in infant mortality and increase adult and child immunization rates in nonwhite racial and ethnic populations. The EHDI grant program is managed by the Department of Health's Centers for Health Equity and Community Health. The legislation contains a blank appropriation for FY 2019.

Assumptions

We assume the FY 2019 appropriation is ongoing and includes \$500,000 for grants and the necessary resources to effectively administer the activity. The legislation would expand the size and scope of the EHDI grant program, requiring additional staff and administrative resources. We assume that 10 EDHI grantees would be selected through a RFP process or funding to current grantees to receive a grant of \$50,000 starting in FY 2019. Eligible grantees would include those outlined as eligible to other EHDI funding and able to implement activities to address prenatal care access and utilization. The funding would likely align with infant mortality reduction activities.

The bill would require an additional quarter-time staff person to identify evidence-based practices related to prenatal care access and utilization. It would also require an additional quarter-time staff to address the financial monitoring of the grants per state and department guidance. The EHDI grants often support small community-based organizations that may require additional support and technical assistance in implementing the grant program.

Some of the additional 0.5 FTE staff responsibilities include:

- · Developing expertise in this topic area.
- Working across the department (with our Community and Family Health division) to assure quality evidencebased programing.
- Developing appropriate guidance for solicitation of competitive applicants for the funding.
- · Providing grant fiscal and programmatic oversight.

We assume other operating costs of approximately \$3,000 for the supplies, communications, computing, materials and

travel expenses for the 0.50 full-time equivalent staff.
