Bill Description

This bill allows a provider in St. Louis County to receive a Group Residential Housing (GRH) supplemental service rate of \$700 per person per month compared to the standard rate of \$482.84 per person per month.

Assumptions

It is assumed that number of recipients will gradually increase from an estimated 20 women in FY18 (based on current data) to reach full capacity of 35 women by FY21. GRH payments will increase by \$217 per person per month under the new bill.
