Bill Description

This bill provides for retroactive driver's license reinstatement for certain individuals whose licenses were suspended due to failure to appear in court or driving after revocation or suspension (169.92 subd 4, 171.24 subd 1, 171.16 subd 2).

Assumptions

Assume data regarding suspensions will remain on the driver's record and not be expunged.

Assume Department of Public Safety Driver and Vehicle Services Division (DVS) is unable to determine the reason for a court-ordered suspension of driving privileges under 2020 Minnesota Statutes 171.16 as the courts did not inform DVS of the underlying conviction providing the basis for the suspension.

Assume individuals who have had their driving privileges suspended based on a court order under 2020 Minnesota Statutes 171.16 will need to provide evidence to DVS of the nature of the underlying conviction in order to be eligible for reinstatement.

Assume all individuals eligible for reinstatement must pay a single reinstatement fee of \$20.

Assume individuals eligible for reinstatement under these changes is subject to all other requirements to obtain a valid driving credential, such as knowledge or skills examinations.

Assume 120 hours MNDRIVE programming to identify eligible individuals, update conditions for reinstatement, and generate the required written notification, at a total cost of \$24,000 (120 hours of programming x \$200 per hour = \$24,000). Assume DVS can absorb this \$24,000 in the DVS technology account (special revenue fund).

Assume 8,026 customers would be eligible for reinstatement under these changes (data from MNDRIVE). Assume DVS is required to send a written notice to these individuals at their last known address to make them aware of their eligibility for reinstatement.

Assume the cost of printing and sending a letter to eligible customers to be \$5,281.56 (printing costs: 8,026 customers x \$0.06 = \$481.56; postage estimated by Minnesota Department of Administration to be \$4,800; \$481.56 + \$4,800 = \$5,281.56).

Assume DVS cannot calculate potential revenue that may result from the retroactive reinstatement of these individuals. Some individuals have been suspended for many years, may have moved out of state and are no longer interested in obtaining a Minnesota driving privilege, may have a hold on their driving privileges in another state, do not wish to meet other requirements to obtain a valid driving credential (such as examination), or otherwise will choose not to pay the reinstatement fee. Assume DVS cannot estimate the revenue nor can DVS determine in which fiscal years individuals may choose to pay the reinstatement fee.

Assume effective date for programming and implementation to be August 1, 2023. Assume DVS must send all notification letters no later than December 1, 2023.
