1.9 (1) the name, residence, telephone number, and driver's license number or
1.10 nonqualification certificate number, if any, of the proposed transferee;

1.11 (2) the sex, date of birth, height, weight, and color of eyes, and distinguishing physical
1.12 characteristics, if any, of the proposed transferee;

1.13 (3) a statement that the proposed transferee authorizes the release to the local police
1.14 authority of commitment information about the proposed transferee maintained by the
1.15 commissioner of human services, to the extent that the information relates to the proposed
1.16 transferee's eligibility to possess a pistol or semiautomatic military-style assault weapon
1.17 under section 624.713, subdivision 1; and

11.10 Subdivision 1. **Definitions.** (a) As used in this section, the following terms have the
11.11 meanings provided in this subdivision.

11.12 (b) "Firearms dealer" means a person who is licensed by the United States Department
11.13 of Justice, Bureau of Alcohol, Tobacco, Firearms and Explosives, under United States Code,
11.14 title 18, section 923(a).

11.15 (c) "State or federally issued identification" means a document or card made or issued
11.16 by or under the authority of the United States government or the state that contains the
11.17 person's name, residence address, date of birth, and photograph and is of a type commonly
11.18 accepted for the purpose of identification of individuals.

11.19 (d) "Unlicensed person" means a person who does not hold a license under United States
11.20 Code, title 18, section 923(a).

11.21 Subd. 2. **Background check and evidence of identity.** An unlicensed person is prohibited
11.22 from transferring a pistol or semiautomatic military-style assault weapon to any other
11.23 unlicensed person, unless: (1) the transfer is made through a firearms dealer as provided
11.24 for in subdivision 3; or (2) the transferee presents a valid transferee permit issued under
11.25 section 624.7131 and a current state or federally issued identification.

11.26 Subd. 3. **Background check conducted by federally licensed firearms dealer.** (a)
11.27 Where both parties to a prospective transfer of a pistol or semiautomatic military-style
11.28 assault weapon are unlicensed persons, the transferor and transferee may appear jointly
11.29 before a federally licensed firearms dealer with the firearm and request that the federally
11.30 licensed firearms dealer conduct a background check on the transferee and facilitate the
11.31 transfer.

12.1 (b) Except as otherwise provided in this section, a federally licensed firearms dealer
12.2 who agrees to facilitate a transfer under this section shall:

12.3 (1) process the transfer as though transferring the firearm from the dealer's inventory to
12.4 the transferee; and

12.5 (2) comply with all requirements of federal and state law that would apply if the firearms
12.6 dealer were making the transfer, including at a minimum all background checks and record
12.7 keeping requirements. The exception to the report of transfer process in section 624.7132,
12.8 subdivision 12, clause (1), does not apply to transfers completed under this subdivision.

12.9 (c) If the transferee is prohibited by federal law from purchasing or possessing the
12.10 firearm, or not entitled under state law to possess the firearm, neither the federally licensed
12.11 firearms dealer nor the transferor shall transfer the firearm to the transferee.

12.12 (d) Notwithstanding any other law to the contrary, this section shall not prevent the
12.13 transferor from:

12.14 (1) removing the firearm from the premises of the federally licensed firearms dealer, or
12.15 the gun show or event where the federally licensed firearms dealer is conducting business,
12.16 as applicable, while the background check is being conducted, provided that the transferor
12.17 must return to the federally licensed firearms dealer with the transferee before the transfer
12.18 takes place, and the federally licensed firearms dealer must take possession of the firearm
12.19 in order to complete the transfer; and

12.20 (2) removing the firearm from the business premises of the federally licensed firearms
12.21 dealer if the results of the background check indicate the transferee is prohibited by federal
12.22 law from purchasing or possessing the firearm, or not entitled under state law to possess
12.23 the firearm.

12.24 (e) A transferee who consents to participate in a transfer under this subdivision is not
12.25 entitled to have the transfer report returned as provided for in section 624.7132, subdivision
12.26 10.

12.27 (f) A firearms dealer may charge a reasonable fee for conducting a background check
12.28 and facilitating a transfer between the transferor and transferee pursuant to this section.

12.29 Subd. 3. **Record of transfer; required information.** (a) Unless a transfer is made
12.30 through a firearms dealer as provided for in subdivision 3, when two unlicensed persons
12.31 complete the transfer of a pistol or semiautomatic military-style assault weapon, the transferor
12.32 and transferee must complete a record of transfer on a form designed and made publicly
12.33 available without fee for this purpose by the superintendent of the Bureau of Criminal

13.1 Apprehension. Each page of the record of transfer must be signed and dated by the transferor
13.2 and the transferee and contain the serial number of the pistol or semiautomatic military-style
13.3 assault weapon.

13.4 (b) The record of transfer must contain the following information:

13.5 (1) a clear copy of each person's current state or federally issued identification;

13.6 (2) a clear copy of the transferee permit presented by the transferee; and

13.7 (3) a signed statement by the transferee swearing that the transferee is not currently
13.8 prohibited by state or federal law from possessing a firearm.

13.9 (c) The record of transfer must also contain the following information regarding the
13.10 transferred pistol or semiautomatic military-style assault weapon:

13.11 (1) the type of pistol or semiautomatic military-style assault weapon;

13.12 (2) the manufacturer, make, and model of the pistol or semiautomatic military-style
13.13 assault weapon; and

13.14 (3) the pistol or semiautomatic military-style assault weapon's manufacturer-assigned
13.15 serial number.

13.16 (d) Both the transferor and the transferee must retain a copy of the record of transfer
13.17 and any attachments to the record of transfer for 20 years from the date of the transfer. A
13.18 copy in digital form shall be acceptable for the purposes of this paragraph.

13.19 **Subd. 4. Compulsory production of a record of transfer; gross misdemeanor**
13.20 **penalty.** (a) Unless a transfer was completed under subdivision 3, the transferor and
13.21 transferee of a pistol or semiautomatic military-style assault weapon transferred under
13.22 subdivision 4 must produce the record of transfer when a peace officer requests the record
13.23 as part of a criminal investigation.

13.24 (b) A person who refuses or is unable to produce a record of transfer for a firearm
13.25 transferred under this section in response to a request for production made by a peace officer
13.26 pursuant to paragraph (a) is guilty of a gross misdemeanor. A prosecution or conviction for
13.27 violation of this subdivision is not a bar to conviction of, or punishment for, any other crime
13.28 committed involving the transferred firearm.

13.29 **Subd. 5. Immunity.** A person is immune to a charge of violating this section if the person
13.30 presents a record of transfer that satisfies the requirements of subdivision 4.

13.31 **Subd. 6. Exclusions.** (a) This section shall not apply to the following transfers:

- 14.1 (1) a transfer by or to a federally licensed firearms dealer;
- 14.2 (2) a transfer by or to any law enforcement agency;
- 14.3 (3) to the extent the transferee is acting within the course and scope of employment and
- 14.4 official duties, a transfer to:
- 14.5 (i) a peace officer, as defined in section 626.84, subdivision 1, paragraph (c);
- 14.6 (ii) a member of the United States armed forces, the National Guard, or the Reserves of
- 14.7 the United States armed forces;
- 14.8 (iii) a federal law enforcement officer; or
- 14.9 (iv) a security guard employed by a protective agent licensed pursuant to chapter 326;
- 14.10 (4) a transfer between immediate family members, which for the purposes of this section
- 14.11 means spouses, domestic partners, parents, children, siblings, grandparents, and
- 14.12 grandchildren;
- 14.13 (5) a transfer to an executor, administrator, trustee, or personal representative of an estate
- 14.14 or a trust that occurs by operation of law upon the death of the former owner of the firearm;
- 14.15 (6) a transfer of an antique firearm as defined in section 624.712, subdivision 3;
- 14.16 (7) a transfer of a curio or relic, as defined in Code of Federal Regulations, title 27,
- 14.17 section 478.11, if the transfer is between collectors of firearms as curios or relics as defined
- 14.18 by United States Code, title 18, section 921(a)(13), who each have in their possession a
- 14.19 valid collector of curio and relics license issued by the United States Department of Justice,
- 14.20 Bureau of Alcohol, Tobacco, Firearms and Explosives;
- 14.21 (8) the temporary transfer of a firearm if:
- 14.22 (i) the transfer is necessary to prevent imminent death or great bodily harm; and
- 14.23 (ii) the person's possession lasts only as long as immediately necessary to prevent such
- 14.24 imminent death or great bodily harm;
- 14.25 (9) transfers by or to an auctioneer who is in compliance with chapter 330 and acting in
- 14.26 the person's official role as an auctioneer to facilitate or conduct an auction of the firearm;
- 14.27 and
- 14.28 (10) a temporary transfer if the transferee's possession of the firearm following the
- 14.29 transfer is only:
- 14.30 (i) at a shooting range that operates in compliance with the performance standards under
- 14.31 chapter 87A or is a nonconforming use under section 87A.03, subdivision 2, or, if compliance

15.1 is not required by the governing body of the jurisdiction, at an established shooting range
15.2 operated consistently with local law in the jurisdiction;

15.3 (ii) at a lawfully organized competition involving the use of a firearm, or while
15.4 participating in or practicing for a performance by an organized group that uses firearms as
15.5 part of the performance;

15.6 (iii) while hunting or trapping if the hunting or trapping is legal in all places where the
15.7 transferee possesses the firearm and the transferee holds all licenses or permits required for
15.8 hunting or trapping;

15.9 (iv) at a lawfully organized educational or instructional course and under the direct
15.10 supervision of a certified instructor, as that term is defined in section 624.714, subdivision
15.11 2a, paragraph (d); or

15.12 (v) while in the actual presence of the transferor.

15.13 (b) A transfer under this subdivision is permitted only if the transferor has no reason to
15.14 believe:

15.15 (1) that the transferee is prohibited by federal law from buying or possessing firearms
15.16 or not entitled under state law to possess firearms;

15.17 (2) if the transferee is under 18 years of age and is receiving the firearm under direct
15.18 supervision and control of an adult, that the adult is prohibited by federal law from buying
15.19 or possessing firearms or not entitled under state law to possess firearms; or

15.20 (3) that the transferee will use or intends to use the firearm in the commission of a crime.

15.21 **EFFECTIVE DATE.** This section is effective August 1, 2023, and applies to crimes
15.22 committed on or after that date."

15.23 Amend the title accordingly
