

A bill for an act

relating to capital investment; authorizing spending to acquire and better public land and buildings and for other improvements of a capital nature with certain conditions; modifying prior appropriations; modifying programs; providing for disaster relief; providing for the sale and issuance of state bonds; providing for the sale, conveyance, and disposition of state bond-financed property; appropriating money; amending Minnesota Statutes 2014, sections 85.015, subdivision 6; 240A.09; 462A.37, subdivision 5, by adding a subdivision; Laws 2008, chapter 179, sections 7, subdivision 22; 16, subdivision 5, as amended; Laws 2009, chapter 93, article 1, section 11, subdivision 4, as amended; Laws 2010, chapter 189, section 15, subdivision 5, as amended; Laws 2012, chapter 293, section 3, subdivision 18; Laws 2013, chapter 136, section 4, as amended; Laws 2014, chapter 294, article 1, sections 15, subdivision 2; 16, subdivisions 5, 9; 18, subdivisions 3, 4; 21, subdivisions 3, 10, 12, 13, 16, 18, 23; Laws 2014, chapter 295, section 10, subdivision 12; proposing coding for new law in Minnesota Statutes, chapter 16A.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

ARTICLE 1

APPROPRIATIONS

Section 1. CAPITAL IMPROVEMENT APPROPRIATIONS.

The sums shown in the column under "Appropriations" are appropriated from the bond proceeds fund, or another named fund, to the state agencies or officials indicated, to be spent for public purposes. Appropriations of bond proceeds must be spent as authorized by the Minnesota Constitution, article XI, section 5, paragraph (a), to acquire and better public land and buildings and other public improvements of a capital nature, or as authorized by the Minnesota Constitution, article XI, section 5, paragraphs (b) to (j), or article XIV. Unless otherwise specified, money appropriated in this act for a capital program or project may be used to pay state agency staff costs that are attributed directly

2.1 to the capital program or project in accordance with accounting policies adopted by the
 2.2 commissioner of management and budget. Unless otherwise specified, the appropriations
 2.3 in this act are available until the project is completed or abandoned subject to Minnesota
 2.4 Statutes, section 16A.642. Unless otherwise specified in this act, money appropriated in
 2.5 this act for activities under Minnesota Statutes, sections 16B.307, 84.946, and 135A.046,
 2.6 should not be used for projects that can be financed within a reasonable time frame under
 2.7 Minnesota Statutes, section 16B.322 or 16C.144.

2.9 **Sec. 2. UNIVERSITY OF MINNESOTA**

2.10 **Subdivision 1. Total Appropriation** **\$ 26,529,000**

2.11 To the Board of Regents of the University
 2.12 of Minnesota for the purposes specified in
 2.13 this section.

2.14 **Subd. 2. Minnesota Poultry Testing Laboratory**
 2.15 **- Willmar** **8,529,000**

2.16 To design, construct, furnish, and equip the
 2.17 expansion and renovation of the Minnesota
 2.18 Poultry Testing Laboratory in Willmar,
 2.19 including facility upgrades to substantially
 2.20 improve the laboratory's efficiency and
 2.21 ability to meet testing requirements, respond
 2.22 to avian influenza and other diseases of
 2.23 poultry, and effectively serve its client base.

2.24 **Subd. 3. St. Paul Campus Veterinary Isolation**
 2.25 **Facility Replacement** **18,000,000**

2.26 To demolish two obsolete veterinary
 2.27 isolation laboratories and predesign, design,
 2.28 construct, furnish, and equip a veterinary
 2.29 biocontainment facility on the St. Paul
 2.30 campus, including large and small animal
 2.31 holding spaces.

2.32 The appropriation in this subdivision is
 2.33 intended to cover approximately two-thirds

3.1 of the cost of the project. The remaining
3.2 costs must be paid from university sources.

3.3 **Subd. 4. Unspent Appropriations**

3.4 Upon substantial completion of a project
3.5 authorized in this section and after written
3.6 notice to the commissioner of management
3.7 and budget, the Board of Regents must use
3.8 any money remaining in the appropriation
3.9 for that project for HEAPR under Minnesota
3.10 Statutes, section 135A.046. The Board
3.11 of Regents must report by February 1 of
3.12 each even-numbered year to the chairs of
3.13 the house of representatives and senate
3.14 committees with jurisdiction over capital
3.15 investment and higher education finance, and
3.16 to the chairs of the house of representatives
3.17 Ways and Means Committee and the senate
3.18 Finance Committee, on how the remaining
3.19 money has been allocated or spent.

3.22 **Subdivision 1. Total Appropriation** **\$ 31,943,000**

3.23 To the Board of Trustees of the Minnesota
3.24 State Colleges and Universities for the
3.25 purposes specified in this section.

3.26 **Subd. 2. Anoka Technical College** **2,114,000**

3.27 To design, renovate, furnish, and equip the
3.28 automotive and manufacturing technology
3.29 training spaces.

3.30 **Subd. 3. Dakota County Technical College** **7,733,000**

3.31 To complete design, renovate, furnish,
3.32 and equip classroom and lab space for
3.33 transportation and emerging technologies
3.34 programs.

- 4.1 Subd. 4. Minnesota West Community and
 4.2 Technical College; Canby and Jackson
 4.3 Campuses 3,267,000
- 4.4 (a) \$2,410,000 of this appropriation is to
 4.5 design and install a geothermal HVAC
 4.6 system, and remove and replace associated
 4.7 mechanical systems, on the Canby campus.
- 4.8 (b) \$857,000 of this appropriation is to design
 4.9 and consolidate the power line training
 4.10 program spaces by demolishing Building
 4.11 "B" and the current off-campus power line
 4.12 training space, and construct and equip a
 4.13 new indoor power line training addition
 4.14 and exterior truck port on the Jackson main
 4.15 campus.

- 4.17 To complete the design of and construct,

- 4.23 (a) Except as provided in paragraph (b), the
 4.24 Board of Trustees shall pay the debt service
 4.25 on one-third of the principal amount of state
 4.26 bonds sold to finance projects authorized
 4.27 by this section. After each sale of general
 4.28 obligation bonds, the commissioner of
 4.29 management and budget shall notify the
 4.30 board of the amounts assessed for each year
 4.31 for the life of the bonds.
- 4.32 (b) The board need not pay debt service
 4.33 on bonds sold to finance HEAPR. Where a
 4.34 nonstate match is required, the debt service is
 4.35 due on a principal amount equal to one-third

5.1 of the total project cost, less the match
5.2 committed before the bonds are sold.

5.3 (c) The commissioner of management and
5.4 budget shall reduce the board's assessment
5.5 each year by one-third of the net income
5.6 from investment of general obligation bond
5.7 proceeds in proportion to the amount of
5.8 principal and interest otherwise required to
5.9 be paid by the board. The board shall pay its
5.10 resulting net assessment to the commissioner
5.11 of management and budget by December
5.12 1 each year. If the board fails to make
5.13 a payment when due, the commissioner
5.14 of management and budget shall reduce
5.15 allotments for appropriations from the
5.16 general fund otherwise available to the board
5.17 and apply the amount of the reduction to
5.18 cover the missed debt service payment. The
5.19 commissioner of management and budget
5.20 shall credit the payments received from the
5.21 board to the bond debt service account in
5.22 the state bond fund each December 1 before
5.23 money is transferred from the general fund
5.24 under Minnesota Statutes, section 16A.641,
5.25 subdivision 10.

5.26 **Subd. 7. Unspent Appropriations**

5.27 (a) Upon substantial completion of a project
5.28 authorized in this section and after written
5.29 notice to the commissioner of management
5.30 and budget, the board must use any money
5.31 remaining in the appropriation for that
5.32 project for HEAPR under Minnesota
5.33 Statutes, section 135A.046. The Board
5.34 of Trustees must report by February 1 of
5.35 each even-numbered year to the chairs of

6.1 the house of representatives and senate
 6.2 committees with jurisdiction over capital
 6.3 investment and higher education finance, and
 6.4 to the chairs of the house of representatives
 6.5 Ways and Means Committee and the senate
 6.6 Finance Committee, on how the remaining

6.8 (b) The unspent portion of an appropriation
 6.9 for a project in this section that is complete is
 6.10 available for HEAPR under this subdivision,
 6.11 at the same campus as the project for which
 6.12 the original appropriation was made and the
 6.13 debt service requirement under subdivision 6
 6.14 is reduced accordingly. Minnesota Statutes,
 6.15 section 16A.642, applies from the date of the
 6.16 original appropriation to the unspent amount
 6.17 transferred.

6.31 (a) For the state share of flood hazard
 6.32 mitigation grants for publicly owned capital
 6.33 improvements to prevent or alleviate flood

7.3 (b) Levee projects, to the extent practical,
7.4 shall meet the state standard of three feet
7.5 above the 100-year flood elevation.

7.6 (c) Project priorities shall be determined
7.7 by the commissioner, as appropriate, based
7.8 on need and consideration of available
7.9 leveraging of federal, local, and state funds.

7.10 (d) \$10,000,000 of this appropriation is for
7.11 a grant to Otter Tail County for publicly
7.12 owned capital improvements to address
7.13 flooding and high-water conditions on Little
7.14 McDonald Lake, Devil's Lake, Kerbs Lake,
7.15 and Paul Lake. Notwithstanding the match
7.16 requirements in Minnesota Statutes, section
7.17 103F.161, subdivision 2, this appropriation
7.18 does not require a local match.

7.19 (e) To the extent that the cost of a project
7.20 exceeds two percent of the median household
7.21 income in a municipality or township
7.22 multiplied by the number of households in the
7.23 municipality or township, this appropriation
7.24 is also for the local share of the project.

7.25 **Subd. 3. Unspent Appropriations**

7.26 The unspent portion of an appropriation for
7.27 a project in this section that is complete,
7.28 upon written notice to the commissioner
7.29 of management and budget, is available
7.30 for asset preservation under Minnesota
7.31 Statutes, section 84.946. Minnesota Statutes,
7.32 section 16A.642, applies from the date of the
7.33 original appropriation to the unspent amount
7.34 transferred.

8.2 **Subdivision 1. Total Appropriation** **\$ 11,026,000**

8.3 To the commissioner of the Pollution Control
8.4 Agency for the purposes specified in this

8.6 **Subd. 2. Capital Assistance Program** **9,276,000**

8.7 (a) This appropriation is for the solid waste
8.8 capital assistance grants program under
8.9 Minnesota Statutes, section 115A.54.

8.10 (b) Of this appropriation: \$600,000 is for
8.11 a grant to Clay County for phase 1 of an
8.12 integrated solid waste system; \$600,000 is
8.13 for a grant to McLeod County for phase 1 of
8.14 an integrated solid waste system; \$56,000 is
8.15 for a project in Dodge County; and \$20,000
8.16 is for a project in Western Lake Superior
8.17 Sanitary District.

8.18 (c) \$8,000,000 of this appropriation is for a
8.19 grant to Polk County for phase 1 of a regional
8.20 integrated solid waste management system.

8.21 This appropriation is not available until the
8.22 agency determines that an amount sufficient
8.23 to complete the project is committed from
8.24 nonstate sources. An additional renewable
8.25 energy component shall not be mandated as
8.26 a requirement of this project to qualify for
8.27 funding under this section.

9.3 To the Board of Water and Soil Resources
 9.4 for grants to local governments in Area II

 9.7 systems. This appropriation is not available
 9.8 until the board determines that \$1 has been
 9.9 committed from nonstate sources for every
 9.10 \$3 of state grant.

9.20 (a) To complete the design of, and to
 9.21 construct, repair, improve, renovate, restore,
 9.22 furnish, and equip the expanded restoration
 9.23 elements of the State Capitol Building and
 9.24 grounds, and any associated asbestos and
 9.25 hazardous materials abatement, including
 9.26 but not limited to: (1) water infiltration,
 9.27 settlement, and deterioration on the plaza,
 9.28 terrace, and stairs; (2) visitor access and
 9.29 bus loading and unloading; (3) decorative
 9.30 painting; (4) cove molding; (5) accessibility,
 9.31 safety, and security for the South Loggia; (6)
 9.32 landscaping on Lot O; and (7) modifications
 9.33 to Aurora Avenue.
