1.7 Section 1. Minnesota Statutes 2016, section 3A.02, subdivision 4, is amended to read:

1.8 Subd. 4. **Deferred annuities augmentation.** (a) The deferred retirement allowance of
1.9 any former legislator must be computed as provided in subdivision 1 on the basis of allowable
1.10 service and augmented as provided herein. (b) ~~The required reserves applicable to the deferred~~
1.11 ~~retirement allowance, determined as of the date the benefit begins to accrue using an~~
1.12 ~~appropriate mortality table and an interest assumption of six percent, must be augmented~~
1.13 by interest compounded annually from the first of the month following the termination of
1.14 active service, or July 1, 1973, whichever is later, to the ~~first day of the month in which the~~
1.15 ~~allowance begins to accrue~~ effective date of retirement, at the following ~~annually~~
1.16 ~~compounded~~ rate or rates:

1.17 (1) five percent until January 1, 1981;

1.30 June 30, 1989, and to any other covered employee who has become at least 55 years old
1.31 and whose annuity is higher when calculated under section 352.115, subdivision 3, paragraph

2.1 (b), in conjunction with this subdivision than when calculated under section 352.115,
2.2 subdivision 3, paragraph (a), in conjunction with subdivision 1. A covered employee who
2.3 retires before the normal retirement age shall be paid the normal retirement annuity provided
2.4 in section 352.115, subdivisions 2 and 3, paragraph (b), reduced ~~so that~~ as described in
2.5 clause (1) or (2), as applicable.

2.6 (1) For covered employees who retire on or after July 1, 2018, the reduced annuity is
2.7 the actuarial equivalent of the annuity that would be payable to the employee if the employee
2.8 deferred receipt of the annuity until normal retirement age and the annuity amount were
2.9 augmented at an the applicable annual rate of three percent₂, compounded annually₂, from
2.10 the day the annuity begins to accrue until the normal retirement age. The applicable annual
