1.4 Subd. 4. **Case management service provider.** (a) "Case management service provider"  
1.5 means a case manager or case manager associate employed by the county or other entity  
1.6 authorized by the county board to provide case management services specified in section  
1.7 245.4711.

1.8 (b) A case manager must:

1.9 (1) be skilled in the process of identifying and assessing a wide range of client needs;

1.10 (2) be knowledgeable about local community resources and how to use those resources  
1.11 for the benefit of the client;

1.12 (3) have a bachelor's degree in one of the behavioral sciences or related fields including,  
1.13 but not limited to, social work, psychology, or nursing from an accredited college or  
1.14 university or meet the requirements of paragraph (c); and

1.15 (4) meet the supervision and continuing education requirements described in paragraphs  
1.16 (d), (e), and (f), as applicable.

1.17 (c) Case managers without a bachelor's degree must meet one of the requirements in  
1.18 clauses (1) to (3):

1.19 (1) have three or four years of experience as a case manager associate as defined in this  
1.20 section;

1.21 (2) be a registered nurse without a bachelor's degree and have a combination of  
1.22 specialized training in psychiatry and work experience consisting of community interaction  
1.23 and involvement or community discharge planning in a mental health setting totaling three  
1.24 years; or

2.1 (3) be a person who qualified as a case manager under the 1998 Department of Human  
2.2 Service waiver provision and meet the continuing education and mentoring requirements  
2.3 in this section.

2.4 (d) A case manager with at least 2,000 hours of supervised experience in the delivery  
2.5 of services to adults with mental illness must receive regular ongoing supervision and clinical  
2.6 supervision totaling 38 hours per year of which at least one hour per month must be clinical  
2.7 supervision regarding individual service delivery with a case management supervisor. The  
2.8 remaining 26 hours of supervision may be provided by a case manager with two years of  
2.9 experience. Group supervision may not constitute more than one-half of the required  
2.10 supervision hours. Clinical supervision must be documented in the client record.

2.11 (e) A case manager without 2,000 hours of supervised experience in the delivery of  
2.12 services to adults with mental illness must:

2.13 (1) receive clinical supervision regarding individual service delivery from a mental  
2.14 health professional at least one hour per week until the requirement of 2,000 hours of  
2.15 experience is met; and

2.16 (2) complete 40 hours of training approved by the commissioner in case management  
2.17 skills and the characteristics and needs of adults with serious and persistent mental illness.

2.18 (f) A case manager who is not licensed, registered, or certified by a health-related  
2.19 licensing board must receive 30 hours of continuing education and training in mental illness  
2.20 and mental health services every two years.

2.21 (g) A case manager associate (CMA) must:

2.22 (1) work under the direction of a case manager or case management supervisor;

2.23 (2) be at least 21 years of age;

2.24 (3) have at least a high school diploma or its equivalent; and

2.25 (4) meet one of the following criteria:

2.26 (i) have an associate of arts degree in one of the behavioral sciences or human services;

2.27 (ii) be a certified peer specialist under section 256B.0615;

2.28 (iii) be a registered nurse without a bachelor's degree;

2.29 (iv) within the previous ten years, have three years of life experience with serious and  
2.30 persistent mental illness as defined in section 245.462, subdivision 20; or as a child had  
2.31 severe emotional disturbance as defined in section 245.4871, subdivision 6; or have three

3.1 years life experience as a primary caregiver to an adult with serious and persistent mental  
3.2 illness within the previous ten years;

3.3 (v) have 6,000 hours work experience as a nondegreed state hospital technician; or

3.4 (vi) ~~be a mental health practitioner as defined in section 245.462, subdivision 17, clause~~  
3.5 ~~(2)~~ have at least 6,000 hours of supervised experience in the delivery of services to persons  
3.6 with mental illness.

3.7 Individuals meeting one of the criteria in items (i) to (v) may qualify as a case manager  
3.8 after four years of supervised work experience as a case manager associate. Individuals  
3.9 meeting the criteria in item (vi) may qualify as a case manager after three years of supervised  
3.10 experience as a case manager associate.

3.11 (h) A case management associate must meet the following supervision, mentoring, and  
3.12 continuing education requirements:

3.13 (1) have 40 hours of preservice training described under paragraph (e), clause (2);

3.14 (2) receive at least 40 hours of continuing education in mental illness and mental health  
3.15 services annually; and

3.16 (3) receive at least five hours of mentoring per week from a case management mentor.

3.17 A "case management mentor" means a qualified, practicing case manager or case management  
3.18 supervisor who teaches or advises and provides intensive training and clinical supervision  
3.19 to one or more case manager associates. Mentoring may occur while providing direct services  
3.20 to consumers in the office or in the field and may be provided to individuals or groups of  
3.21 case manager associates. At least two mentoring hours per week must be individual and  
3.22 face-to-face.

3.23 (i) A case management supervisor must meet the criteria for mental health professionals,  
3.24 as specified in section 245.462, subdivision 18.

3.25 (j) An immigrant who does not have the qualifications specified in this subdivision may  
3.26 provide case management services to adult immigrants with serious and persistent mental  
3.27 illness who are members of the same ethnic group as the case manager if the person:

3.28 (1) is currently enrolled in and is actively pursuing credits toward the completion of a  
3.29 bachelor's degree in one of the behavioral sciences or a related field including, but not  
3.30 limited to, social work, psychology, or nursing from an accredited college or university;

3.31 (2) completes 40 hours of training as specified in this subdivision; and

4.1 (3) receives clinical supervision at least once a week until the requirements of this  
4.2 subdivision are met."

5.3 Subd. 7. **Crisis stabilization services.** Crisis stabilization services must be provided by  
5.4 a mental health professional or a mental health practitioner, as defined in section 245.462,  
5.5 subdivision 17, who works under the clinical supervision of a mental health professional  
5.6 and for a crisis stabilization services provider entity and must meet the following standards:

5.7 (1) a crisis stabilization treatment plan must be developed which meets the criteria in  
5.8 subdivision 8;

5.9 (2) services must be delivered according to the treatment plan and include face-to-face  
5.10 contact with the recipient by qualified staff for further assessment, help with referrals,  
5.11 updating the crisis stabilization treatment plan, supportive counseling, skills training, and  
5.12 collaboration with other service providers in the community; and

5.13 (3) mental health practitioners must have completed at least 30 hours of training in crisis  
5.14 intervention and stabilization during the past two years."
