1.22 submitted to the Legislative Coordinating Commission Subcommittee on Employee  
1.23 Relations on October 29, 2015, and implemented after 30 days as provided in Minnesota  
1.24 Statutes, section 3.855, subdivision 2, is ratified.

1.25 Subd. 9. **Middle Management Association.** The labor agreement between the state  
1.26 of Minnesota and the Middle Management Association, submitted to the Legislative  
1.27 Coordinating Commission Subcommittee on Employee Relations on October 29, 2015,
