- 6. **HF3272 (Albright)** State Board of Investment; investments authorized, and investments exempted from market capitalization restriction.
- 7. **HF4431 (Becker-Finn)** Minnesota Tribal Nations government-to-government relationship established.
- 8. **HF4257 (Moller)** Teacher license renewal requirements amended to include mental illness training, and rulemaking required. *PENDING REFERRAL*
- 9. **HF3976 (Dehn)** Aiding and abetting felony murder sentencing task force established, and report required.
- 10. **HF3423 (Sandell)** Water quality standards for perfluoroalkyl and polyfluoroalkyl substances funding provided, rulemaking authorized, and money appropriated in the Water Division.

- 11. **HF1842 (Wagenius)** Energy; utility arbiter of disputes clarified. *PENDING REFERRAL*
- 12. **HF4181 (Stephenson)** Electric vehicle purchase for state fleet preference established, purchase rebates provided, automobile dealer grants to defray manufacturer certification cost awarded, and money appropriated. *PENDING REFERRAL*
