Dear Senator Champion, Representative Hassan and members of the conference committee,

As you move into the conference committee to confer about the final jobs bill, we want to thank both the Senate and House for including Bolder Options in their omnibus bills. We are grateful to our authors and co-authors, to the committee chairs, and to the members of both committees for welcoming our testimony and considering our request. We are especially appreciative of the tremendous learning and leadership opportunity this provided for our young testifiers.

Mentoring is a research-based strategy proven to make a difference in young people's lives through improved educational outcomes, expanded social emotional skills, and stronger relationships. Our new alumni programming that introduces career exploration in early adolescence is necessary - and interest is surging. After a full year of 1:1 mentorship, our young people want to keep setting and achieving goals that will lead them to bolder options for their futures. This funding will help us quickly respond to the demand from our young participants for this programming, also allowing us to host cohorts in both the Twin Cities and in Rochester.

Bolder Options is fortunate to have been included in both the House and Senate bills. In the end, we respectfully urge the conference committee to adopt the Senate language with \$250,000 allocated for Bolder Options (vs. \$200,000 in the House bill). This is half of our original request of \$500,000 but would still be transformational for our organization and our youth.

The Coalition of Asian American Leaders (CAAL) writes to encourage members of the conference committee to adopt the House position that includes \$500,000 to CAAL to support Asian women entrepreneurs.

Asian women entrepreneurs are living and working across Minnesota. As one of the fastest growing demographics of business owners, Asian women run grocery stores, bakeries, and organic food distribution programs. They own home healthcare businesses, laundromats, and beauty salons. Their businesses and services are meeting a wide variety of community needs and are a backbone for many local economies. Unfortunately, specific barriers stand in the way of the ability of Asian women entrepreneurs to develop and grow these businesses. These include language barriers, a lack of relationships with banking institutions, a lack of familiarity with government programs supporting businesses, and discrimination and negative stereotypes.

Targeted investment in Asian women entrepreneurs, through a trusted community network, is needed to overcome these barriers and will benefit the state as a whole. The **House Jobs omnibus legislation provides a one-time appropriation of \$500,000 through CAAL**, a trusted nonprofit organization with a strong community network and proven track record of supporting Asian Minnesotan women entrepreneurs and business owners. This appropriation will provide business owners with technical assistance to navigate assistance programs and build relationships with financial institutions. It will also offer direct financial support and support the development of a peer network of Asian women entrepreneurs.

When we equip Asian women entrepreneurs with the tools to turn their ideas into businesses, we begin building intergenerational wealth for the Asian Minnesotan community. We create pathways out of low-wage work for Asian American families, and our children have better educational and career outcomes because of it. We boost the economic stability of the Asian Minnesotan community – and Minnesota overall.

Re: PFA Language in the Omnibus Jobs Bill

Dear Senator Champion, Representative Hassan, and members of the Omnibus Jobs Conference Committee,

On behalf of the Coalition of Greater Minnesota Cities (CGMC), I am writing to express our support for one provision in the Senate version of this bill and urge its adoption. Specifically, we urge the adoption of language increasing the grant limits for two of the Public Facilities Authority (PFA) programs, which can be found in Article 8 of the Senate Policy Article, at pages R 99 – R101, lines 23.25 – 25.21. The Governor included this change in his bonding proposal as well.

The PFA helps fund water, sewer, wastewater, and related projects in Minnesota. Almost every city or responsible government unit works with PFA to help underwrite a portion or all of the funding for their projects. Much of the funding available to cities is in the form of low-interest loans, but there are two types of grants that may be available to local governments that qualify. Water Infrastructure Fund (WIF) grants are awarded to cities to pay for wastewater and drinking water projects based on an affordability formula that looks at the impacts construction will have on water rates. The Point Source Implementation Grant (PSIG) program helps local governments pay for construction projects that are required to meet pollution reduction mandates placed on their wastewater and related facilities. The requirements that make a project eligible for a PSIG grant, such as an effluent limit on phosphorus, are important for the health of Minnesota's waters, but they are still a state mandate that increases the cost of a project.

The cap on the upper limit of these grants has not changed since 2017 and currently sits at \$5 million for WIF and \$7 million for PSIG. The Senate language would increase the cap to \$10 million for WIF and \$12 million for PSIG, better reflecting the actual cost of projects. Changing these caps would help the financial health of our cities and their residents, protect the environment, and promote construction jobs.

We urge you to adopt this Senate language from pages R99 – R101 of the Senate policy section. Thank you for allowing us to comment on this legislation.

Dear Chair Champion, Chair Hassan and Committee Members,

On behalf of Children's Minnesota, I am writing to encourage conference committee adoption of a key provision included in HF5205 which grants \$2,000,000 to PFund Foundation to empower LGBTQ+ individuals and families seeking refuge in Minnesota.

Children's Minnesota is the state's largest pediatric healthcare system. We serve a diverse patient population, and nearly 50% of our patients are enrolled in Medicaid. To best serve our community, we opened our Gender Health program five years ago, understanding that transgender and gender-diverse kids and their families needed a medical partner, resource, and ally along their journey.

After the Minnesota Transgender Refuge bill was signed into law in 2023, a PFund survey found that over 150 individuals and families were moving to Minnesota to seek refuge. Additionally, our Gender Health clinic at Children's Minnesota saw a 30% increase in new patient calls as states surrounding us restricted or banned gender-affirming care. We welcome transgender and gender diverse children and families with open arms, but our waitlist is growing, and our team at Children's Minnesota and our colleagues in the Twin Cities are outmatched by the demand. While the Trans Refuge law was an important first step to protecting essential health care for transgender and gender-diverse youth, we must do more.

To improve access to care, we are calling on Minnesota lawmakers to invest in the infrastructure we need to provide specialized training for more providers who can approach this care in alignment with well-established clinical guidelines. Specifically, we are asking for investment in a grant-funded training program to help expand access to essential healthcare for transgender and gender-diverse youth by leveraging the expertise and care systems already in place.

This critical funding will not only expand access to care for those already living in Minnesota (our waitlist prior to the passage of the Trans Refuge Bill was already over a year-long), it will also welcome those new families moving to Minnesota by delivering on our promise that our state would be a place where essential health care would be protected and accessible for their families. This investment in healthcare infrastructure will improve health outcomes, particularly mental health outcomes, for transgender and gender diverse youth in Minnesota while at the same time, attracting new families to our state who bring with them workforce skills, financial resources, real estate investment and contribute to a culture of inclusion.

When transgender and gender-diverse kids are seen, heard, and believed, they do better. When we support kids to be who they are, we know they can grow up happy, healthy, safe, and strong. With this investment, we can continue to show our unwavering support for transgender and gender diverse children and provide more of the essential care they need.



Dear Sen. Champion, Rep. Hassan, and members of the Conference Committee:

Thank you for hearing our bill in the Senate Jobs and Economic Development Committee during this legislative session. I am writing on behalf of EquaSpace in reference to SF 5289 and to urge you to adopt the House language on the bill.

EquaSpace exists to provide space and infrastructure support, including education and training related to running an effective and efficient nonprofit. Nonprofit jobs comprise 13% of the workforce in MN, and, just like any other field, require training to ensure they continue to be abreast of any shifts and legal requirements that apply to the sector.

In addition, by becoming a tenant of EquaSpace, there is a cost savings of around \$15,000 annually per organization (as cited by the Nonprofit Centers Network, 2019). As a result of the budgetary relief, EquaSpace tenants can re-allocate financial resources towards mission work, and often can add new employees, a significant point of interest of this committee.

EquaSpace is slated to open in September 2024, with a growing number of nonprofits that are attracted to becoming tenants. With the current design of the space, we can house 20+ organizations with over 250 employees. Many of these nonprofits are slated to add new positions to their teams.

EquaSpace is a compliment to Propel Nonprofits in that we help organizations implement the advice and technical assistance that they provide. As Henry Jiménez, CEO and President of Propel Nonprofits, shares, "By offering nonprofit leaders and staff a chance to stay flexible and efficient, and to work near other motivated leaders who also serve their communities providing services and resources to those who need it most, EquaSpace would enhance the nonprofit ecosystem."

We appreciate your support and urge you to adopt the House position.

GMCC (founded as Greater Minneapolis Council of Churches) is a 118-year-old interfaith, multicultural non-profit social services agency located in South Minneapolis that has worked to address unequal access to resources and further equity through a variety of programs and services.

I want to thank you for the inclusion of funding in both the House and Senate Jobs and Economic Omnibus budget bills (House Article 1, lines 8.5-8.15/Senate Article 1, lines 50.28-50.31) for our LakeStreet Youth Labs program.

LakeStreet Youth Labs program is a year-round program offering no-cost quality STEM programming and workforce development opportunities for low-income families that can't afford to pay for extracurricular activities or academic support. This program focuses on the Phillips neighborhoods of South Minneapolis and serves low-income BIPOC youth and their families.

These services originated at the onset of COVID-19 and the vast majority of youth in our community come from households with little to no computer access; no high-speed internet; no resources to hire tutors; and parents or guardians with limited digital navigation and English language skills, which made distance learning impossible.

Demand for our program is increasing rapidly and this additional funding will be used to meet that demand and serve more students.

We thank you for your work this session and for supporting GMCC's legislative request.

Dear Sen. Champion, Rep. Hassan, and members of the Conference Committee on SF 5289:

Entrusted Committee members, I am writing to ask you to please consider including Hired's job retention services provision in the final bill, which reads:

\$280,000 is for a grant to Hired to create services for low-income Minnesotans designed to increase job retention by offering a continuum of employment coaching, navigation, and support services to economically disadvantaged employees leading to a more stable workforce for employers.

Thank you for hearing testimony and considering this concept that helping people to **navigate barriers to keep a job** increases job retention rates as a critical step after someone has invested so much to upskill and get a job.

And, thank you for your support of **Hired's direct appropriation (DA) last year** for a completely different purpose: **expanding career pathway trainings** at Hired. I'm delighted to let you know that those funds are being well utilized and training more people! Our DA contract was signed in October and in the first six months of the contract, 69 people completed training and 25 people have started a new job! **We're right on track with 30% of job placement goal met while being a quarter through the contract.** Thanks to your support last year, we're doing the important work of getting people ready for family-sustaining wages and careers that will help them build wealth.

I know that approaching the legislature for additional support this year is raising questions. And please know, that in our 56+ years of connecting people with family-stabilizing services and employment, we know that **employment equity doesn't stop at getting that good job.** After people have worked hard to upskill and prepare for a job, most often our contracts and grants end, which means that our services and the trusting relationships we've established with people stop. Our current funding supports only superficial monthly connections, for a brief time, even though the people we have been working with are experiencing a very fragile transition into employment.

Hired's bill this session addresses this critical need and persistent gap. It is all about **helping people navigate a strong start in their jobs.** Today, many of the people we work with face historic, systemic, and situational barriers and inequities to not just finding, but also *sustaining*, employment. We have found they need **on-site and mobile services including coaching** to prepare for a benefits cliff as they become eligible for employment benefits and ineligible for other benefits they may have been relying upon for housing, childcare, healthcare, or food. They also need **support connecting to or navigating needed community resources, and support services to address unexpected emergencies or reemerging barriers that could end employment...**very often transportation, childcare and food barriers.

The majority of people we serve are people of color, have low and very-low incomes, and face critical disparities in employment, education, health outcomes, and more. Hired is part of the solution in closing persistent employment disparity gaps in the State, and in addressing inequities that are connected with income and employment disparities.

As Jamin Cook testified—the second shift supervisor at Medtronic—**people definitively need help navigating the workplace and life barriers to keep their jobs.** That pilot project with Medtronic was great, and **demonstrated the difference that intensive job retention can make.**

I do ask that you please accept the House position and include Hired's bill. This direct appropriation will help workers in high growth sectors keep their jobs, advance in a company, and build stability and wealth for their families, all while stabilizing workers for employers.

In 2023:

- 82% complete the first 90 days of the program and 100% are housing stable
- 70% of our graduates have jobs secured when they graduate

The state benefits because Jobs Foundation helps break the cycle of poverty and recidivism and replace it with productive, talented, tax paying citizens who dream of a better future. One of our graduates made the Dean's list at college after he was able to stabilize his life during our program. Another graduate bought her first house, providing a home for her family. 

We are asking that you support the House position in the Omnibus Jobs, Economic Development, Supplemental Appropriations bill which appropriates \$250,000 to the statewide Minnesota Family Resiliency Partnership.

The Minnesota Family Resiliency Partnership has provided excellent outcomes and has always had strong bipartisan support since its inception in 1979 and we are grateful that that support continues today. As the only pre-employment program providing family stabilization through trauma-informed care, our services are unique and unduplicated. We are often the first step for people looking to enter or re-enter the workforce due to abandonment, divorce, death or disability of a spouse or partner.

We are facing a constant demand for services and a decrease in funding which currently comes from a portion of marriage license and divorce filing fees.

Last year, this one-of-a-kind self-sufficiency program achieved a 97% success rate, meaning participants are employed, continuing their education, or have achieved the goals they set at in-take!

Each of the 6 providers that make up the program covers a service area of seven to eleven resource-limited, rural counties, covering hundreds of miles, with only one or two staff. Participants we are serving often don't have reliable transportation or gas money to reach us, sometimes they don't even have a driver's license. We must go to them. Often, our program is "the only game in town". Increased funding would increase our capacity to provide these unique services.

Additional funding would also allow for direct support dollars for participants to eliminate barriers to their training or job search needs that are not covered by other service providers such as minor car repairs, gas cards, a month's car insurance or even help with driver's training. We could provide appropriate shoes, uniforms, or even childcare funds until they get that first paycheck.

We respectfully request that you support the House position in the omnibus bill. Thank you for all that you do for your constituency and our participants!

Both omnibus bills contain a number of good policy and funding provisions that will advance economic development and will increase investment in residents in our community to support holistic workforce development supports. The requests we have target low income, diverse communities and those experiencing the highest barriers to economic opportunity and employment.

(21) \$100,000 is for a grant to Ramsey County for a subgrant with Milestone Community Development to provide competitive grants for culturally specific East African-led youth workforce development programs.

**HF 5205, Article Workforce Development Appropriations, Section 3 DEED Appropriations
(Starting Page 58, line 27)**

(41) \$150,000 is for a grant to Ramsey County for a Justice Impact Navigator to support Ramsey County residents who have a justice impact or who are reentering the community after incarceration to connect to resources with a focus on employment and training supports. Funds will be used for a navigator pilot and other administrative expenses such as outreach, marketing, and resources for residents; and

(42) \$150,000 is for a grant to Ramsey County for a Digital Equity Specialist to support Ramsey County residents with digital literacy resources and skills to connect to employment and training supports. Funds must be used for a digital navigator pilot serving in Ramsey County Career Labs and community-based locations and other administrative expenses, such as outreach, marketing, and resources for residents.

Lastly, there is a clarifying policy change on census tract language we need included in your conference committee report in order to actually distribute the appropriation we received in your 2023 bill. The clarifying language in the amendment that is in HF 5205 works, and we appreciate the adoption.

**HF 5205, Article 4 Workforce Development section 8
(Page 86, line 26)**

(ccc) \$500,000 each year is for a grant to Ramsey County for a technology training pathway program focused on intergenerational community tech work for residents who are at least 18 years old and no more than 24 years old and who live in a census tract that has a poverty rate of at least 20 percent as reported in the most recently completed decennial census published by the United States Bureau of the Census whose household income is at or below 200 percent of the federal poverty level. Grant money may be used for program administration, training, training stipends, wages, and support services. This is a onetime appropriation.

Chair Hassan, President Champion & Members of the Omnibus Jobs, Economic Development, Supplemental Appropriations Conference Committee:

I write to you today in support of a \$1,000,000 million dollar appropriation included in House File 5205, the House Omnibus Jobs & Economic Development Omnibus bill, that benefits the Entrepreneur Fund.

This appropriation will be used for loan capital to continue to grow the Entrepreneur Fund's lending capacity. These dollars will be used to lend to small businesses. The Entrepreneur Fund will use this grant to leverage \$12,000,000 in new capital for lending to small businesses.

The Entrepreneur Fund's business lending has grown at a remarkable pace and, with tightening credit in banking this year, will continue to grow. On an annual basis, the Entrepreneur Fund issues 300-600 loans, totaling between \$23-\$27 million dollars, and provides no cost services to 1,600-2,200 entrepreneurs in north and central Minnesota.

Efund provides access to capital where it is difficult to find – *business* types that include restaurants, retail, start-ups, turnarounds, and high growth; or *borrowers* with limited net worth, limited down payment, newer to an industry, and lower credit scores. In short, Efund extends capital where it is difficult to find but real opportunity exists. All Efund borrowers receive access to Efund consulting services, at no cost, to drive successful outcomes. This unique combination of services and capital results in high start-up survival rates, a well performing portfolio, and revenue growth that exceeds their regional peers despite being "unbankable".

We started working with Entrepreneur Fund back in 2018, and with their help we were able to secure several SBA Microloans as well as a USDA loan. This funding was essential to help us grow our 3 businesses, Spokengear Cyclery, Cedar Coffee Company, and Cedaero. Our 3 businesses (retail, food service and manufacturing) now employ over 30 people in our small town of Two Harbors.

In addition to help with finance, we also participated in several educational programs put on by Entrepreneur fund and provided free of charge to us.

During COVID Times we worked with Entrepreneur Fund to secure several grants as well as defer payments on our SBA Loans. Again this help was essential for us to actually grow our business in this uncertain time.

Thank you again for including funding for the Entrepreneur Fund in the House bill. We respectfully request that the conference committee agree to this provision for this important funding.

Thank you for your continued support of Summit Academy located in North Minneapolis. We are grateful for the Jobs and Economic Development Omnibus Budget bill this session.

As the conference committee convenes and finalizes the Jobs and Economic Development Omnibus Budget bill this session, we respectfully request inclusion of \$150,000 for Summit Academy. The original bill -- HF5012 (Hassan)/SF4646 (Champion) -- was introduced this session and a \$150,000 appropriation in FY25 is included in the House Jobs and Economic Development Omnibus Budget bill.

As you know, employers in the Twin Cities metro area reported an over 25,400 job vacancies in Health & Social Assistance in 2022. This accounted for over one-quarter (25.9%) of the region's total job vacancies. The number of job vacancies in this field is up 75% from 2017, with an overall median wage of \$29.63 per hour.

Summit Academy is building its network of advisory and employer partners to support the development of a Dental Assistant training program. The \$150,000 appropriation from the Workforce Development Fund (WDF) included in the House bill will provide Summit Academy with matching funds as the organization works with private sector partners to develop and implement a new Dental Assistant Program. Summit Academy's current industry advisory partners include the Minnesota Board of Dentistry, Park Dental, Aspen, and Heartland. The launch of this program is scheduled for the Summer 2025.

Thank you for your efforts to invest in the economic vibrancy of Minnesota. This biennium the House and Senate have made child care a priority and we look forward to a continued partnership to address the ongoing child care crisis in Minnesota.

WomenVenture deeply appreciates the inclusion of \$1.0 million in the House Omnibus Jobs, Economic Development, Labor, and Industry bill to support Minnesota's small family child care providers through capital grants and business support.

In 2023, the legislature invested \$1 million in capital grants and business development through WomenVenture to help Minnesota's vital child care providers run sustainable businesses, enhance facilities, and reduce burnout.

Between January (applications opened) and March, WomenVenture deployed grant and loan funding for 28 child care businesses totaling nearly \$400,000, which expended all planned dollars for calendar year 2024. Among other uses, funds were used to tear down a wall to expand enrollment and boost revenue by \$30,000, to add a sport court to attract older kids, and to renovate space to accommodate 24/7 care to support shift-work.

The need is real. We have a wait list for those seeking funding support when we reopen applications for calendar year 2025. And the need is statewide. WomenVenture's 2023 funds support child care providers throughout Minnesota, from the Twin Cities, Detroit Lakes, Waconia, Mayer, Shafer, and Litchfield.

Supporting these small businesses through small capital grants and loans, along with business support is necessary to preserve Minnesota's existing child care capacity and to hopefully create additional capacity as well.

A thriving, equitable and economically growing state requires the full participation of its workforce. And that participation requires accessible, quality child care. Sincerely,
