1.8 (2) to approve applications for private detective and protective agent licenses and issue,
1.9 or reissue licenses as provided in sections 326.32 to 326.339;

1.10 (3) to deny applications for private detective and protective agent licenses if the applicants
1.11 do not meet the requirements of sections 326.32 to 326.339; upon denial of a license
1.12 application, the board shall notify the applicant of the denial and the facts and circumstances
1.13 that constitute the denial; the board shall advise the applicant of the right to a contested case
1.14 hearing under chapter 14;

1.15 (4) to enforce all laws and rules governing private detectives and protective agents; ~~and~~

1.16 (5) to suspend or revoke the license of a license holder or impose a civil penalty on a
1.17 license holder for violations of any provision of sections 326.32 to 326.339 or the rules of

1.19 (6) to investigate and refer for prosecution all criminal violations by individuals and
1.20 entities; and

1.21 (7) to investigate and refer for prosecution any individuals and entities operating as
1.22 private detectives or protective agents without a license.

2.2 Subd. 2. **Identification card.** An identification card must be issued by the license holder
2.3 to each employee. The card must be in the possession of the employee to whom it is issued
2.4 at all times. The identification card must contain the license holder's name, logo (if any),
2.5 address or Minnesota office address, and the employee's photograph and physical description.
2.6 The card must be signed by the employee and by the license holder, qualified representative,
2.7 or Minnesota office manager. The card must be presented upon request."

2.11 Subdivision 1. **Basis for action.** The board may revoke or suspend or refuse to issue or
2.12 reissue a private detective or protective agent license if:

2.13 (1) the license holder violates a provision of sections 326.32 to 326.339 or a rule adopted
2.14 under those sections;

2.15 (2) the license holder has engaged in fraud, deceit, or misrepresentation while in the
2.16 business of private detective or protective agent;

2.17 (3) the license holder has made a false statement in an application submitted to the board
2.18 or in a document required to be submitted to the board; ~~or~~

2.19 (4) the license holder violates an order of the board; or

2.20 (5) the individual or entity previously operated without a license."
