2024 Help America Vote Act (HAVA) Election Security Funds State Match Request

\$1M awarded to MN from FY2024 Further Consolidated Appropriations Act

Planned use: Support the Office's Security Navigator program which assists state and local election administrators to ensure physical and cyber security

20 percent state match required within 2 years of allocation (April 2026)

ASK: \$200,000 one-time funds

March 5 Presidential Nomination Primary

3 major political parties

Separate ballots by party

585,991 total ballots cast

13.6% of the voting eligible population

First election with translated voting instructions and sample ballots

August 13 State Primary

543,982 total ballots cast

12.8% of the voting eligible population

New laws

- Permanent absentee voting
- Expanding student housing list as proof of residence option for Election Day registration

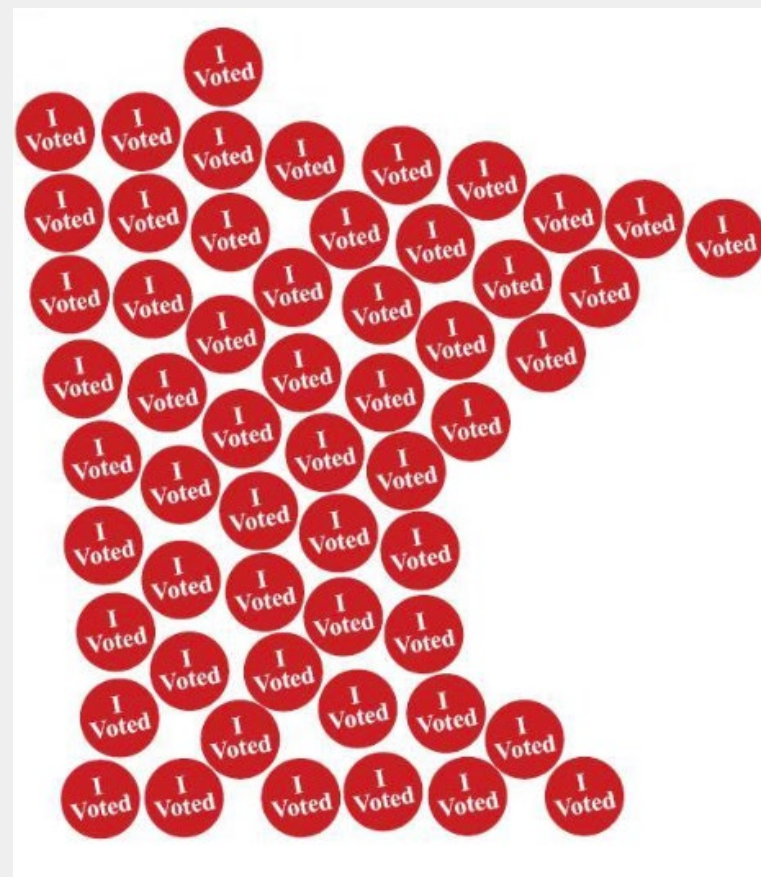

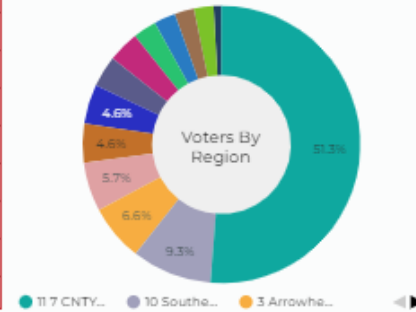

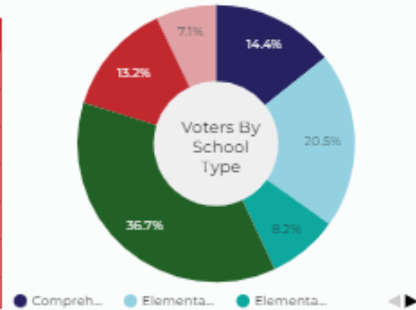

Office of the Secretary of State Duties

- Chief state election official
- Train and certify county election administrators
- Administer the Statewide Voter Registration System (SVRS)
- Administer database of candidates and election results
- Test and certify election equipment
- Voter education and outreach
- Post-election audits
- Rulemaking authority
- Not a legal advisor or enforcement agency

County Elections Duties

- **Voter registration:** data entry, verification, and maintenance
- **Ballots:** layout, proofing, and printing for state elections
- **Voting equipment:** purchase, program, test
- **Absentee voting:** issue ballots, absentee ballot boards
- **Training and certification:** municipal clerks and election judges
- **Election results:** compile, transmit to OSS website, review, proof
- **Post-election:** canvass, hand count audit, post voting history and enter Election Day registrations, forward potential violations to county attorney as appropriate

Ballot Development

1. Ballot content is finalized - Notices of election, ballot question language, candidate filings, certification of candidates

2. Ballot files are available for county/vendor ballot programmers

3. Ballot layout and design is completed

4. Ballot proofs are prepared and reviewed - County shares with other jurisdictions to review and approve their ballot content

5. Ballot proofs are approved and ballots are printed

*Minn. Stat. 204B.44 – legal process to correct an error or omission in preparing or printing any official ballot

Municipal Elections Duties

- Determine precinct boundaries, polling locations
- Hire election judges & assign to precincts
- Additional duties, if designated:
 - Train and certify election judges
 - Administer absentee balloting
 - Health care facility absentee voting

Election Security Navigator Program

A brief history: (...now in our 6th year!)

- 2020: All about Cyber Security
 - County networks and elections support systems
- 2022: Add in Physical Security, (+ Mis/Dis/Mal-Information)
 - County personnel, offices, polling places
- 2024: All-Hazards Approach (“Ready for Anything!”)
 - Readiness and Preparedness: *From malicious actors to natural disasters*

- Support local election leaders as the “*Trusted Sources*”

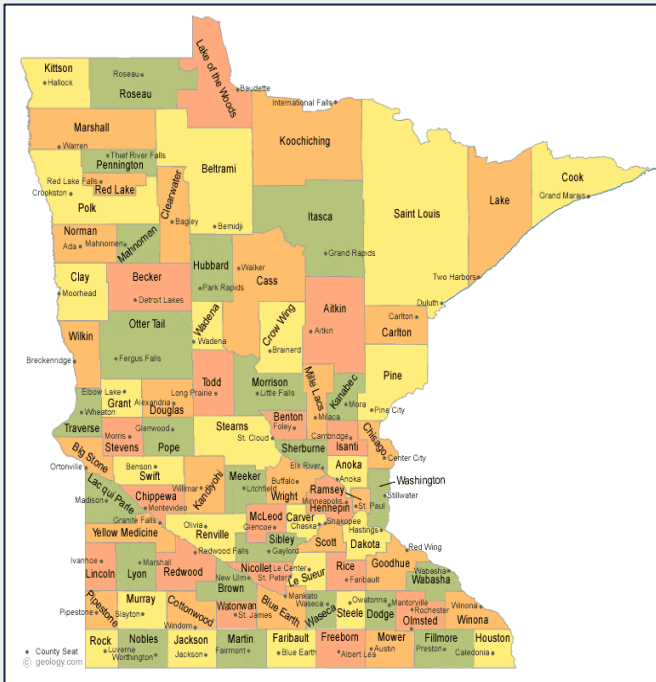

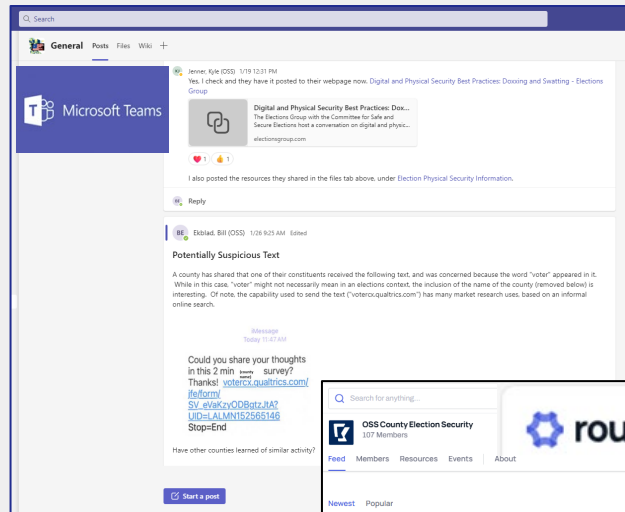

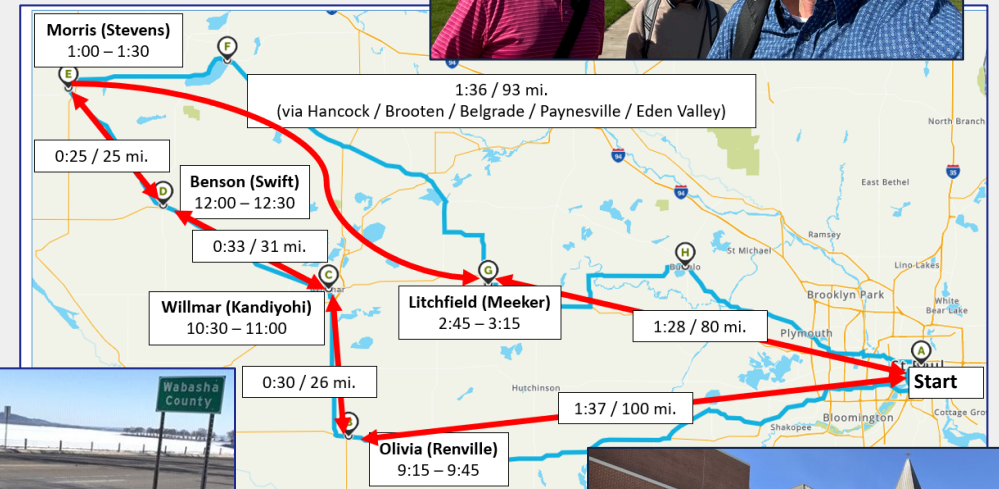

Absentee Voting

- 1.3 million absentee ballots cast
- Expanded direct balloting & AB processing timelines
- Additional weekend and evening hours
 - More than 120,000 in-person absentee ballots accepted on the 3 additional weekend days
 - More than 20% of all in-person absentee ballots were accepted over the final three days (Sat. Nov. 2, Sun. Nov. 3, Mon. Nov. 4)
- Temporary AB locations
- Absentee ballot chain of custody

Unofficial Election Results Reported Starting After 8 p.m.

November 5, 2024

SAINT PAUL – Unofficial election results will begin to be reported on [Office of the Minnesota Secretary of State's website](#) starting at 8 p.m.

Unofficial election results from all precincts are reported by county officials directly to the Office of the Secretary of State. Results posted on the Office's website include combined vote counts for both polling place and mail/absentee ballots. The results are not separated by voting method.

Absentee Ballot Deadline Later Starting This Year

In 2023, the deadline for receiving absentee ballots by a county or city who administers absentee voting was extended by five hours from 3 p.m. to 8 p.m. These ballots may be delivered by a voter or by the postal service or other package delivery.

Most counties are expected to process the absentee ballots received by 8 p.m. before reporting any election results. Results may be reported later than in the past due to this change.

Counties have the option under state law to instead report the results of absentee ballots received between 3 p.m. and 8 p.m. separately. If so, the county must report the number remaining to be processed, which will be shown on the [Unprocessed Absentee Ballot Counts webpage](#).
