Bill Description

This bill appropriates \$1,000,000 in FY 2018 and \$1,000,000 in FY 2019 from the general fund to the commissioner of health for grants to non-profit organizations to prevent the spread of HIV/AIDS. It targets those communities at high risk for HIV infection and those already living with HIV/AIDS. The bill requires a competitive request for proposal (RFP) process and gives priority to organizations that have experience dealing with issues related to HIV/AIDS. The grants would be administered through the HIV/AIDS program in the Infectious Disease Epidemiology and Control Division (IDEPC).

Assumptions

Each year, we fund similar HIV grants as described in the legislation across 28 project grants (23 are state funded; 5 are federally funded), which are managed by 19 different organizations (some organizations receive multiple awards). At MDH, these grants are managed by 4 federally funded FTE grant managers. We anticipate that adding \$1,000,000 in new HIV grants would require one additional Health Program Representative Senior (1 FTE). Their duties would include developing and overseeing the Requests for Proposals and competitive grant process, negotiate and develop contractual agreements, monitor process and outcome evaluations, conduct site visits and provide technical assistance to funded agencies. We expect to give awards many different organizations to provide HIV prevention services reaching several target populations dependent upon epidemiological data.
