#### **Bill Description**

HF 9037-0 Emer Med Svcs Reg Adopt Rules Amends M.S. 144E.16 by adding subdivision 9 and 10

Subdivision 9: Rules authorizing patientsssisted medication administration. Establishes rules authorizing EMT's, AEMT's and paramedics to assist a patient with administering specific prescription medications.

Subdivision 10: Rules establishing standards for care coordinators. Establishes rules related to standards for ambulance services to communicate with patient and with patient caregivers, concerning patient's health condition. Establish rules for medical directors to participate in care coordination for patients.

## **Assumptions**

Emergency Medical Services (EMS) in Minnesota is physician-driven. Adopting substantive rules consistent with the requirements of this bill will require workgroup meetings with physician medical directors in order to craft the specific rule language. Moreover, given the comprehensive, complex, and potentially controversial topics necessitating rules as required by the bill, and in particular the resulting touchpoints throughout EMS in Minnesota, crafting specific rule language also will necessitate the formation of a committee to advise on the development of the rules.

The bill does not specify a timeline for adoption of the rules. The EMSRB assumes that, as with most legislation mandating rule adoption by executive branch agencies, the expectation is 18 months from the effective date of the law requiring the rule.

Given the nature and complexity of the bill's subject matter, and due to the anticipated issues it will create within the medical director community as well as with other EMS stakeholders, it is assumed the costs associated with rulemaking will be \$50,000. This amount includes: expenditures for research and drafting, subject matter outside consultants, and legal fees; salary for the services of a state employee with another agency experienced in the rulemaking process to assist the EMSRB; publishing fees in the State Register; fees related to postage, transcripts, and photocopying; fees related to in-state travel; board member per diems, possible expert witness fees, and fees related to the Office of Administrative Hearings.
