

Vulnerable Adult Abuse Investigation Quality Improvement Project

Minnesotans expect safe, quality care for older and vulnerable adults living in nursing homes and other care settings. Addressing the investigation backlogs and holding private providers accountable for the care of Minnesota's most vulnerable is a top priority for MDH. To that end, Governor Mark Dayton is bringing together resources from the Department of Human Services and other state agencies to improve the efficiency and effectiveness of investigations. Our top goals include:

- Improving communication with families.
- Replacing an antiquated paper-based records system.
- Reducing the time it takes to process complaints.
- Eliminating the backlog of cases.

Triage and Investigation Update

(02/25/2018)

Triage

- Starting point was 2,321 reports that needed initial review as of January 1, 2018.
- As of February 25, 2018, the team reviewed all 2,321 report: 2,211 were assessed and closed; 89 were recommended for onsite investigation; and 21 were ongoing assessments. MDH expects to complete ongoing assessments by March.
- MDH received 416 new reports for the week ending February 25. Investigation
- The investigation backlog was 826 cases from the period of January 1, 2016 December 31, 2017. As of February 25, 2018, 396 of these investigations were completed. 430 investigations were pending at various stages.

Policy Update

- Governor Dayton and AARP convened an independent Work Group on the Health and Safety of Minnesota Seniors that released a report with recommendation on January 29.
- State agencies are working on the recommendations with advocates and legislators.

Total report and investigation backlog at the start of 2018




Report backlog at the start of 2018



New reports filed as complaints until substantiated and assigned for further investigation.


Reports received week ending 2/25/18*


