1.2 Page 10, delete subdivision 4 and insert:

1.3 "Subd. 4. Dam Renovation, Repair, Removal 15,400,000

1.4 (a) For design, engineering, and construction
1.5 to repair, reconstruct, or remove dams and
1.6 respond to dam safety emergencies. The
1.7 commissioner shall determine project priorities
1.8 as appropriate under Minnesota Statutes,
1.9 sections 103G.511 and 103G.515. Of this
1.10 appropriation:

1.11 (1) \$4,400,000 is for emergencies on
1.12 state-owned dams; for repairs to the Lake
1.13 Bronson dam; and for state dams at Brawner,
1.14 West Leaf Lake, Collinwood, Grindstone
1.15 River, Sullivan, and Willow River;

1.16 (2) \$4,000,000 is for a grant to the city of
1.17 Lanesboro for repair of the Lanesboro dam
1.18 and notwithstanding the match requirements
1.19 in Minnesota Statutes, section 103G.511, does
1.20 not require a nonstate contribution. This
1.21 includes funding for repairs of the hydropower
1.22 system;

1.23 (3) \$500,000 is for a grant to the city of
1.24 Pelican Rapids for engineering work on the
1.25 Pelican Rapids dam;

2.1 (4) \$200,000 is for a grant to the city of Pine
 2.2 River for engineering work on the Norway
 2.3 Lake dam;

2.4 (5) \$200,000 is for a grant to Yellow Medicine
 2.5 County for the Canby R-6 impoundment dam;

2.6 (6) \$100,000 is for a grant to St. Louis County
 2.7 for the Little Stone Lake dam; and

2.8 (7) \$6,000,000 is for a grant to Dakota County
 2.9 to design and construct capital improvements
 2.10 to the hydroelectric generating facility,
 2.11 including replacement of obsolete turbines, at
 2.12 the Byllesby Dam located on the Cannon
 2.13 River.

2.14 (b) If the commissioner determines that a
 2.15 project is not ready to proceed, this
 2.16 appropriation may be used for other projects
 2.17 on the commissioner's priority list."

4.5 human services for a grant to the People's
4.6 Center in Minneapolis to design, renovate,
4.7 improve, construct, and equip a facility that
4.8 provides medical, dental, mental health, and
4.9 wellness services to all patients, regardless of
4.10 their ability to pay. This appropriation is not
4.11 available until the commissioner of
4.12 management and budget confirms that an
4.13 amount sufficient to complete the project has
4.14 been committed from nonstate sources."

7.1 (a) For a grant to the Minneapolis Park and
 7.2 Recreation Board to predesign and design the
 7.3 renovation and expansion of the Brian Coyle
 7.4 Community Center, subject to Minnesota
 7.5 Statutes, section 16A.695. This appropriation
 7.6 does not require a local match.

7.7 (b) The Minneapolis Park and Recreation
 7.8 Board, the Pillsbury United Communities,
 7.9 Hennepin County, institutions of higher
 7.10 education, and neighborhood organizations
 7.11 shall develop an agreement for the use of the
 7.12 existing Brian Coyle Community Center. The
 7.13 lease between the Minneapolis Park and
 7.14 Recreation Board and Pillsbury United
 7.15 Communities shall be reformed prior to the
 7.16 expenditure of any funds for predesign and
 7.17 design.
