#### **Bill Description**

The bill reestablishes the Legislative Water Commission (LWC) which consists of 12 members (six senators, six representatives). Members may receive per diem and reimbursement of expenses as authorized by their respective chamber. The Legislative Coordinating Commission (LCC) must employ staff and contract with consultants as necessary. The commission expires on July 1, 2028.

### **Assumptions**

- 1. The LWC was established first in FY15 under MS 3.886 but then was sunset on July 1, 2019 (FY20).
- 2. The LCC enacted a Subcommittee on Minnesota Water Policy (SMWP) in FY20. The 12-member subcommittee continued to be staffed by the LCC with a director and members were eligible for per diem and reimbursement of expenses for meeting participation.
- 3. We assume that with the reestablishment of the LWC that the LCC would sunset the SMWP. Policy review report and recommendation work will continue under the LWC.
- 4. The LWC will meet in person, with limited remote participation, within the Capitol complex ten times each fiscal year beginning with FY24 with eight of the meetings occurring during interims.
- 5. The legislative members of the commission are eligible for compensation and reimbursement of expenses through the LCC.
- 6. Legislative member meeting participation costs includes the following per member, per legislative interim meeting: per diem (\$86 senators, \$66 representatives), and \$100 round trip mileage (152 round trip mile average). Half of the legislative members will be reimbursed for lodging expenses (\$150/night senators, \$175/night representatives).
- 7. This note does not include any additional cost that non-legislative agencies may incur for interaction with staff and/or participation in meetings as requested by the commission.
- 8. Senate Counsel, Research and Fiscal Analysis will provide support of a 0.03 FTE composite of staff time each fiscal year beginning FY24 (approximately 80 hours). For this fiscal note we assume existing Senate staff will be utilized and costs may be absorbed, although that will depend on the priorities of the legislature and staff time required for competing projects.
- 9. House Research Department and House Fiscal Analysis Department will provide support of a 0.03 FTE composite of staff time each fiscal year beginning FY24 (approximately 80 hours). For this fiscal note we assume existing House

- staff will be utilized and costs may be absorbed, although that will depend on the priorities of the legislature and staff time required for competing projects.
- 10. The SMWP director will continue to serve at a 1.0 FTE capacity but now as LWC director. Compensation cost for the director will include salary, FICA cost, and employer contribution for health insurance and Unclassified retirement plan.
- 11. The office for the LWC director will continue to be within the existing space in the State Office Building. No cost for office space will be incurred.
- 12. Office equipment (computer, monitor) and software will be updated for the director in FY24 and absorbed by the LCC. Other nominal operation cost (printing, supplies staff travel) for each fiscal year will be absorbed by the LCC.
- 13. The LCC will continue to provide administrative oversight and fiscal support services at a .05 FTE (105 hours). For this fiscal note we assume existing LCC staff will be utilized, and cost may be absorbed, although that will depend on the priorities of the legislature and staff time required for competing projects.
- 14. The LCC received a base appropriation of \$145K for the LWC initial enactment beginning FY16 (ML 2014, Ch 312, Art 4, Sec 2, Subd 1) which has continued to be included in the LCC operating budget.
- 15. We assume that the \$145K base appropriation will be ongoing but additional funds will be needed for the reestablished LWC beginning FY24 through FY28. The net new funding need of \$52K each FY beginning FY24 is shown in the table in the Expenditure and/or Revenue Formula section.
