Bill Description

This bill amends an existing statute and establishes a licensure system for speech language pathology assistants that provides full licensure or restricted licensure. The bill sets educational requirements and licensure fees, creates title protection, and details actions for violations of the statute. The program is administered by the Health Occupations Program, Department of Health.

Assumptions

Under the current regulations, Minnesota Department of Health (MDH) licensed speech language pathologists can delegate certain duties to speech language pathology assistants. Under this bill, the Department would begin licensing speech language pathology assistants effective January 1, 2019. This new responsibility would require MDH to hire staff to carry out the licensure and regulatory duties authorized in this bill, an information technology system for administering the program, and other non-personnel costs associated with operating a regulatory program.

Staff workload will be greater in FY2019 as we notify practitioners of new licensing requirements; educate regarding statutory requirements; receive and process initial applications for licensure, including evaluation of supporting documentation. We assume the initial application and subsequent renewals will be accomplished through an online licensing system, including the collection of licensing fees, document uploads, and issuance letters. Ongoing tasks will include processing applications for initial licensure and renewals, responding to questions from practitioners and the public, investigating complaints, and pursuing discipline and enforcement.

The bill requires the commissioner to appoint an additional member to the already-existing advisory council. That individual must be a speech language pathology assistant. The council meets quarterly with a per diem rate of \$55. Expenses to support the advisory council are estimated at \$110 per person per council meeting.

We assume information technology costs of \$6,000 in FY2019 and \$2,100 annually thereafter to:

- Display information through a speech language pathology assistant webpage.
- Track a licensing system and related requirements.
- Track a system of complaints and disciplinary actions.

• Make reports, including the number of licensed speech language pathology assistants, complaint and discipline data, and track program fees and expenditures.

Other operating expenses include direct staff costs for communications and supplies.

There are currently 1,721 speech language pathologists licensed by the Department of Health. We assume that about 20% of the licensed speech language pathologists delegate duties to an unlicensed assistant. We assume that approximately 70 individuals currently employed to assist speech language pathologists, licensed by MDH, will be eligible and will apply for a full unrestricted license; and 275 individuals will be eligible and apply for a restricted license in FY19. We estimate a growth rate of 10% annually as those with a restricted license complete the educational and clinical requirements for an unrestricted license, new students graduate from accredited programs and paraprofessionals employed in educational settings will seek a MDH speech language pathology assistant license.

Because this is an emerging field, we estimate a very small percentage of assistants will choose not to renew their licenses. In order to recover the cost of performing the regulatory activities over a five-year period, the initial fee is \$130 for a two year license, plus a one-time surcharge for processing background checks and a biennial renewal fee of \$120.
