

- 25% are Pell Grant recipients
- 33% are students of color & Native American students (international students not included)
- 20% are first-generation college students (neither parent earned a college degree)
- 17% of our new students each year are transfer students

The Minnesota State Grant is Critical to Minnesota's Future

- After a decade of declining post-secondary enrollment, all Minnesota higher education sectors are finally seeing enrollment increases.
- If the State Grant shortfall is not addressed and grants are rationed, more than 80,000 students will be affected:
 - About 24,000 students who qualify for State Grants will lose them entirely next year.
 - All remaining students will have their grants significantly reduced.
- Our State cannot meet its future workforce needs without achieving higher levels of post-secondary success from students who rely on the State Grant to earn a credential or degree.
- Fully funding the State Grant will keep a promise to students and drive future economic success for Minnesota.
