## Grant Projects:

- MDH signs a grant agreement with each clinic
  - Grantees must submit a Work Plan and a Budget
- All Grantees use funds to continue, expand, and improve services to low-income populations
- Examples:
  - **Hennepin County Care for the Homeless** is providing care in 9 homeless shelters and drop-in sites
  - **Scenic Rivers Health Services** is purchasing dental equipment and supplies for Bigfork and Floodwood clinics
  - **Native American Community Clinic** is increasing cancer screening, and expanding Medication Assisted Therapy for opioid dependent patients
  - **Community Health Services** and **Open Door Health Center** are providing mobile dental services throughout western and southern Minnesota
  - **Neighborhood HealthSource** is offering evening hours at 3 sites
  - **Sawtooth Mountain Clinic** is subsidizing discounts in partnership with other dental providers in Grand Marais
