1.15 for the participant to fulfill the service commitment, including death, total and permanent  
1.16 disability, or temporary disability lasting more than two years.

1.17 ~~(e)~~ (f) "Medical resident" means an individual participating in a medical residency in  
1.18 family practice, internal medicine, obstetrics and gynecology, pediatrics, or psychiatry.

1.19 ~~(f)~~ (g) "Midlevel practitioner" means a nurse practitioner, nurse-midwife, nurse  
1.20 anesthetist, advanced clinical nurse specialist, or physician assistant.

1.22 all licensing or certification necessary to perform duties as a licensed practical nurse  
1.23 or registered nurse.

1.25 of study designed to prepare registered nurses for advanced practice as nurse-midwives.

2.2 program of study designed to prepare registered nurses for advanced practice as nurse  
2.3 practitioners.

2.5           ~~(l)~~ (l) "Physician" means an individual who is licensed to practice medicine in  
2.6 the areas of family practice, internal medicine, obstetrics and gynecology, pediatrics,  
2.7 or psychiatry.

2.8           ~~(m)~~ (m) "Physician assistant" means a person licensed under chapter 147A.
