Bill Description

Amends and clarifies sections of statute that license and regulate home care providers. The Home Care & Assisted Living Program (HCALP) within the Health Regulation Division (HRD) is affected and there is some impact to Licensing and Certification (L&C), which is also in HRD. There is no appropriation, but there is a new fee of \$1,000 for a notification failure.

Assumptions

We do not expect any costs related to this bill. HCALP and L&C will continue to license and regulate home care providers with the existing resources. Most of the amendments provide clarity to existing language. Current law requires temporary license holders to notify MDH within 5 days when they begin to serve clients. The bill may be an effective deterrent at reducing the number of instances when providers fail to notify MDH. We have no reliable way to estimate how many providers would still fail to notify MDH when they begin serving clients, so we are not forecasting any change in revenue for purposes of this fiscal note.
