HF 3766 (Perryman) Licensing and registration of limited lines travel insurance producers and travel retailers provided, and sale and regulation of travel insurance provided

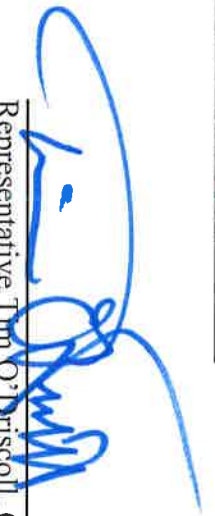
Chair O'Driscoll moved HF3766 before the committee to be laid over for possible inclusion in a future omnibus bill.
