1.5	Section 1. PREPARED MEALS FOOD RELIEF GRANTS.
1.6	Subdivision 1. Establishment. The commissioner of human services shall establish a
1.7	prepared meals grant program to provide hunger relief to Minnesotans experiencing food
1.8	insecurity and who have difficulty preparing meals due to limited mobility, disability, age,
1.9	or resources to prepare their own meal.
1.10	Subd. 2. Eligible grantees. Eligible grantees are nonprofit organizations with a
1.11	demonstrated history of providing and distributing prepared meals customized for the
1.12	population that they serve, including tailoring meals to the cultural, religious, and dietary
1.13	needs of the population served.
1.14	Subd. 3. Application. Applicants for grant funds under this section shall apply to the
1.15	commissioner on the forms and according to the timelines established by the commissioner
1.16	Subd. 4. Allowable uses of grant funds. (a) Eligible grantees must use grant funds
1.17	awarded under this section to provide meals to individuals between 18 and 60 years of age
1.18	experiencing food insecurity and individuals who are not currently eligible for an existing

2.3	Subd. 5. Duties of the commissioner. (a) The commissioner shall develop a process

2.5	(b) In granting funds, the commissioner shall prioritize nonprofit organizations that:
2.6	(1) have demonstrated ability to provide prepared meals to racially and geographically
2.7	diverse populations at greater risk for food insecurity;
