1.5 Subd. 3. **Rate of tax.** The gasoline excise tax is imposed at the following rates:

1.6 (1) E85 is taxed at the rate of ~~17.75~~ 0 cents per gallon;

1.7 (2) M85 is taxed at the rate of ~~14.25~~ 0 cents per gallon; and

1.8 (3) all other gasoline is taxed at the rate of ~~25~~ 0 cents per gallon.

1.9 Sec. 42. Minnesota Statutes 2014, section 296A.08, subdivision 2, is amended to read:

1.10 Subd. 2. **Rate of tax.** The special fuel excise tax is imposed at the following rates:

1.11 (a) Liquefied petroleum gas or propane is taxed at the rate of ~~18.75~~ 0 cents per gallon.

1.12 (b) Liquefied natural gas is taxed at the rate of ~~15~~ 0 cents per gallon.

1.13 (c) Compressed natural gas is taxed at the rate of ~~\$2.174~~ \$0 per thousand cubic  
1.14 feet; or ~~25~~ 0 cents per gasoline equivalent. For purposes of this paragraph, "gasoline  
1.15 equivalent," as defined by the National Conference on Weights and Measures, is 5.66

2.12 fiscal year equals the total amount of debt service from fiscal years 2009 to 2039, and the  
2.13 surcharge is rounded to the nearest 0.1 cent 0 cents."
