### **Bill Description**

The bill would increase penalties and establishes minimum fines for individuals who have repeat violations of driving without a valid license.

A gross misdemeanor is established if the person is found guilty under M.S. 171.24 and is involved in a collision that results in substantial bodily harm or death to another person. There is a provision for a misdemeanor offense (and \$1,500 fine) if a person is found guilty under this section within ten years of their first conviction under this section.

### **Bill Description**

HF3385-0 amends Minn. Stat. § 171.24 (driving without a valid license) by: 1) making it a gross misdemeanor to violate section 171.24 and be involved in a collision resulting in substantial bodily harm or death to another; 2) making it a gross misdemeanor to violate section 171.24 within ten years of the first of two prior convictions; 3) requiring a person convicted of second violation of section 171.24 to pay a minimum fine of \$750; 4) requiring a person convicted of a third or subsequent violation under the new gross misdemeanor provision to pay a minimum fine of \$1,500; 5) authorizing the court to authorize community work service in lieu of fine payment if the court finds the convicted person is indigent or that fine payment would create an undue hardship for the person or the persons immediate family; and 6) providing that nothing in section 171.24, 609.035, or 609.04 limits the power of the state to prosecute or punish a person for conduct that constitutes any other crime under any other law of the state.

#### **Assumptions**

It is assumed that because the provisions of this bill do not create new offenses, and only increase the penalties for certain driving without a valid license offenses, this bill will not result in an increase or decrease in the number of cases filed with the court.

The bill mandates that persons convicted of a second misdemeanor violation of section 171.24 must pay a minimum fine of \$750. Court administration is not in a position or legally authorized to determine a particular defendants prior record or impose a higher fine in certain cases. It is assumed that because misdemeanor driving without a valid license citations may be paid without a court appearance under the Statewide Payables List, all defendants charged by citation with a misdemeanor offense who pay the citation without a court appearance will pay the fine amount stated on the Statewide Payables List.

It is also assumed that although driving without a valid license offenses may be paid without a court appearance under the Statewide Payables List, offenses that involve endangerment to persons or property, and repeat offenses charged by complaint, currently require a court appearance under the Statewide Payable Offense Policy. It is assumed that gross misdemeanor violations of section 171.24 will not require more Judicial Branch resources than misdemeanor violations of section 171.24 that currently require a court appearance.

#### **Expenditure and/or Revenue Formula**

Because the provisions of this bill do not create new offenses, and only increase the penalties for certain driving without a valid license offenses that already require a court appearance, the provisions of this bill are not anticipated to have a measurable fiscal impact on the Judicial Branch.

This bill enhances penalties and establishes minimum fines for repeat violations of driving without a valid license. This bill amends Minnesota Statutes 2014, section 171.24.

Minn. Stat. § 171.24 is amended to include that a person is guilty of a gross misdemeanor if the person violates this section and is involved in a collision resulting in substantial bodily harm or death to another. A person is guilty of a misdemeanor and is subject to the minimum penalty (a fine of at least \$1,500 dollars), if the person violates this section within ten years of the first of two prior convictions under this section.

This bill is effective August 1, 2016, and applies to offenses committed on or after that date.
