114D.30 CLEAN WATER COUNCIL CITIZENS' BOARD.

Subdivision 1. **Creation; duties.** A Clean Water <u>Council Citizens' Board</u> is created to advise on the administration and implementation of this chapter, and foster coordination and cooperation as described in section 114D.20, subdivision 1. The <u>council board</u> may also advise on the development of appropriate processes for expert scientific review as described in section 114D.35, subdivision 2. The Pollution Control Agency shall provide administrative support for the <u>council with the support of other member agencies board</u>. The members of the <u>council board</u> shall elect a chair from the <u>voting</u> members of the <u>council board</u> shall elect a chair from the <u>voting</u> members of the <u>council board</u>.

Subd. 2. **Membership; appointment.** (a) The commissioners of natural resources, agriculture, health, and the Pollution Control Agency, the executive director of the Board of Water and Soil Resources, the Board of Regents of the University of Minnesota, and the Metropolitan Council shall each appoint one person from their respective entity to serve as a nonvoting member of the council. Subd. 3. **Conflict of interest.** A Clean Water <u>Council Citizens' Board</u> member may not participate in or vote on a decision of the <u>council board</u> relating to an organization in which the member has either a direct or indirect personal financial interest. While serving on the Clean Water <u>Council Citizens' Board</u>, a member shall avoid any potential conflict of interest.

- Subd. 4. **Terms; compensation; removal.** The terms of members representing the state agencies and the Metropolitan Council are four years and are coterminous with the governor. The terms of other nonlegislative members of the council board shall be as provided in section 15.059, subdivision 2. Members may serve until their successors are appointed and qualify. Compensation and removal of nonlegislative council board members is as provided in section 15.059, subdivisions 3 and 4. Compensation of legislative members is as determined by the appointing authority. The Pollution Control Agency may reimburse legislative members for expenses. A vacancy on the council may be filled by the appointing authority provided in subdivision 1 for the remainder of the unexpired term.
- Subd. 5. **Implementation plan.** The Clean Water <u>Council Citizens' Board</u> shall recommend a plan for implementation of this chapter and the provisions of article XI, section 15, of the Minnesota Constitution relating to clean water. The recommended plan shall address general procedures and time frames for implementing this chapter, and shall include a more specific implementation work plan for the next fiscal biennium and a framework for setting priorities to address impaired waters consistent with section 114D.20, subdivisions 2 to 7. The <u>council board</u> shall issue a revised plan by December 1 of each even-numbered year.
- Subd. 6. **Recommendations on appropriation of funds.** (a) The Clean Water Council Citizens' Board shall recommend to the governor and the legislature the manner in which money from the clean water fund should be appropriated for the purposes stated in article XI, section 15, of the Minnesota Constitution and section 114D.50.
 - (b) The eouncil's board's recommendations must:
- (1) be to protect, enhance, and restore water quality in lakes, rivers, and streams and to protect groundwater from degradation and ensure that at least five percent of the clean water fund is spent only to protect drinking water sources;
- 3.32 (2) be consistent with the purposes, policies, goals, and priorities in this chapter; and

(3) allocate adequate support and resources to identify degraded groundwater and impaired waters, develop TMDL's, implement restoration of groundwater and impaired waters, and provide assistance and incentives to prevent groundwater and surface waters from becoming degraded or impaired and improve the quality of surface waters which are listed as impaired but have no approved TMDL.

- (c) The <u>eouncil board</u> must recommend methods of ensuring that awards of grants, loans, or other funds from the clean water fund specify the outcomes to be achieved as a result of the funding and specify standards to hold the recipient accountable for achieving the desired outcomes. Expenditures from the fund must be appropriated by law.
- Subd. 7. **Biennial report to legislature.** By December 1 of each even-numbered year, the <u>eouneil board</u> shall submit a report to the legislature on the activities for which money has been or will be spent for the current biennium, the activities for which money is recommended to be spent in the next biennium, and the impact on economic development of the implementation of efforts to protect and restore groundwater and the impaired waters program. The report due on December 1, 2014, must include an evaluation of the progress made through June 30, 2014, in implementing this chapter and the provisions of article XI, section 15, of the Minnesota Constitution relating to clean water, the need for funding of future implementation, and recommendations for the sources of funding.
