I work at Sprout Food Hub in Little Falls. Sprout had the honor of being awarded an LFPA grant and serving our communities through this grant. Countless people were grateful for the food that we sourced from our farmers, growers and producers. We received many thanks, comments of appreciation. Many of our consumers were elderly, on budgets, and spoke of how receiving this food helped them "get by". They were also grateful that it was good food that they were receiving.

Comfortable education occurred, as many younger people had never seen certain vegetables, and didn't know what they were. People my age grew up gardening these vegetables, or eating them regularly. I was able to tell them what they were, give them simple methods for preparing and eating that vegetable they were asking about. I was also able to give tips for "child friendly" introductions to the vegetable. With those who were familiar with the produce, I was able to share different variations of cooking or eating many of the vegetables.

As shared tips or methods, other people also shared how they like to prepare it. This brought about a sense of community, while they were learning about the foods they weren't familiar with, as well as sharing with each other their favorite ways to eat. Diversity in age groups were present. The elderly and retired, young families, and I saw many more young adults than I anticipated seeing.

Please support Minnesota with HF 2102 so that we can support our local growers and producers, but also our people in need of food security.

- Farmers already navigate unpredictable challenges—weather, input costs, land values, disease pressure, and volatile markets. When they enter a contract with the government, they should be able to trust that commitment.
- LFPA keeps food dollars circulating locally by incentivizing organizations and businesses to procure food from farmers in their communities. That money will likely be re-invested back onto the farm, supporting the development of farming operations and our agricultural economy.
- Organizations statewide have relied on this funding to establish wholesale agreements with farmers, providing a stable market for beginning and underserved farmers.
 - Underserved producers have historically missed out on market development opportunities and other forms of support from the federal and state government.
 - One challenge for beginning farmers is securing reliable markets. LFPA partnerships provide a critical source of financial stability during the early, high-risk years of farming.
- This program improves access to fresh, healthy foods for underserved communities across Minnesota, particularly in rural areas where availability is often more limited.
- LFPA doesn't just increase access to local food—it connects people with where their food comes from, growing an understanding of regional agriculture in the state and appreciation for hard working farmers.
