

1.1 moves to amend H.F. No. 1507, the first engrossment, as follows:

1.2 Page 2, line 24, after the period insert "A technology provider does not include a
1.3 not-for-profit organization that has the primary purpose of expanding student access to
1.4 postsecondary education, and that obtains a student's consent to utilize the student's
1.5 educational data for that purpose."

1.6 Page 2, line 25, delete "January 1, 2019" and insert "for the 2019-2020 school year and
1.7 later"

1.8 Page 2, line 30, delete "on an electronic database" and insert "in a technology system,
1.9 including but not limited to an electronic database, software application, or cloud-based
1.10 service"

1.11 Page 3, line 5, after "data" insert ", the identity of the student whose data is affected, the
1.12 date and time of the action, and what action was performed. Information recorded in the
1.13 log-of-use must be retained for at least one year"

1.14 Page 3, after line 7, insert:

1.15 "(c) Paragraph (a), clause (3), does not apply to technology systems that were in use
1.16 prior to January 1, 2019, and that lack the capacity to automatically record actions in a
1.17 log-of-use."

1.18 Page 3, lines 8 and 17, delete "January 1, 2019" and insert "for the 2019-2020 school
1.19 year and later"

1.20 Page 4, line 19, after "data" insert ", the identity of the student whose data is affected,
1.21 the date and time of the action, and what action was performed. Information recorded in
1.22 the log-of-use must be retained for at least one year"

1.23 Page 4, line 22, after "(h)" insert "Within 30 days of the start of each school year," and
1.24 delete "annually"

2.1 Page 4, line 27, delete "opt-out rights provided in" and insert ", if applicable, the parent
2.2 or student's ability to opt-out of any program or activity that allows a technology provider
2.3 to access a student's educational data."

2.4 Page 4, delete lines 28 to 31

2.5 Page 5, delete lines 1 and 2, and insert:

2.6 "(i) A public educational agency or institution must provide parents and students an
2.7 opportunity to inspect a complete copy of any contract with a technology provider."

2.8 Page 5, line 4, delete everything after "who" and insert "opts-out of any program or
2.9 activity that allows a technology provider to access a student's educational data."

2.10 Page 5, delete line 5

2.11 Page 5, line 6, delete "January 1, 2019" and insert "for the 2019-2020 school year and
2.12 later"

2.13 Page 5, line 23, delete the second "or"

2.14 Page 5, line 25, delete the period and insert "; or"

2.15 Page 5, after line 25, insert:

2.16 "(5) the activity is limited to that which is prohibited by paragraph (a), clause (3), and
2.17 is necessary to enforce a school's acceptable-use policy."

2.18 Page 6, lines 1 and 14, delete "January 1, 2019" and insert "for the 2019-2020 school
2.19 year and later"

2.20 Page 6, delete lines 12 and 13 and insert:

2.21 "(c) A postsecondary institution is exempt from subdivisions 13 through 16 of this
2.22 section. This exemption extends to a technology provider for purposes of a contract with a
2.23 postsecondary institution."
