1.5 Subd. 5. **CARMA enrollment.** (a) Subject to ~~paragraphs~~ paragraph (d) ~~and (e)~~, eligible  
1.6 individuals must be automatically enrolled in CARMA, but may decline enrollment. Eligible  
1.7 individuals may enroll in fee-for-service medical assistance. Eligible individuals may change  
1.8 their CARMA elections on an annual basis.

1.9 (b) Eligible individuals must be able to enroll in CARMA through the selection process  
1.10 in accordance with the election period established in section 256B.69, subdivision 4,  
1.11 paragraph (e).

1.12 (c) Enrollees who were not previously enrolled in the medical assistance program or  
1.13 MinnesotaCare can change their selection once within the first year after enrollment in  
1.14 CARMA. Enrollees who were not previously enrolled in CARMA have 90 days to make a  
1.15 change and changes are allowed for additional special circumstances.

1.16 (d) The commissioner may not offer a second health plan to eligible individuals other  
1.17 than, ~~and~~ or in addition to, CARMA except that the commissioner may offer a second health  
1.18 plan to eligible individuals when another health plan is enrolling in MinnesotaCare, if  
1.19 required by federal law or rule. Eligible individuals who do not select a health plan at the  
1.20 time of enrollment must automatically be enrolled in CARMA.

1.21 (e) The commissioner may offer a replacement plan to eligible individuals, as determined  
1.22 by the commissioner, when counties administering CARMA have their contract terminated  
1.23 for cause.

2.1 ~~(e)~~ (f) The commissioner may, on a county-by-county basis, offer a health plan other  
 2.2 than, ~~and in addition to,~~ CARMA to individuals who are eligible for both Medicare and  
 2.3 medical assistance due to age, income, or disability if ~~the commissioner deems it necessary~~  
 2.4 ~~for enrollees to have another choice of health plan. Factors the commissioner must consider~~  
 2.5 ~~when determining if the other health plan is necessary include the number of available~~  
 2.6 ~~Medicare Advantage Plan options that are not special needs plans in the county, the size of~~  
 2.7 ~~the enrolling population, the additional administrative burden placed on providers and~~  
 2.8 ~~counties by multiple health plan options in a county, the need to ensure the viability and~~  
 2.9 ~~success of the CARMA program, and the impact to the medical assistance program there~~

 2.12 second health plan other than CARMA pursuant to paragraphs (d) and (e), eligible enrollees  
 2.13 who do not select a health plan at the time of enrollment must automatically be enrolled in
