# **Bill Description**

This bill amends Minnesota Statute 326B.106 by adding a subdivision which would allow the use of any refrigerant deemed acceptable under United States Code, chapter 42, regardless of state rule or code prohibition/limitation of refrigerant.

#### **Assumptions**

DLI's construction codes and licensing division's building inspection services unit is responsible for the work activities under the Minnesota Mechanical Code. Any alternative refrigerants approved for use in this bill must be contained in equipment which complies with safety standards currently adopted within the Minnesota Mechanical Code. Building inspectors are responsible for ensuring the refrigeration systems and equipment meet current mechanical code requirements. Because DLI is inspecting the system and equipment, and not the refrigerant, this bill has no impact to the work performed by DLI.
