- 1.5 (a) Notwithstanding the public sale provisions of Minnesota Statutes, chapter 282,
- 1.6 St. Louis County may sell tax-forfeited land described in paragraph (c) to an adjoining
- 1.7 landowner under the remaining provisions of Minnesota Statutes, chapter 282.
- 1.8 (b) The conveyance must be in a form approved by the attorney general for not less
- 1.9 than the appraised value of the land. The attorney general may make necessary changes to
- 1.10 the legal description to correct errors and ensure accuracy.

- 2.28 best served if the lands were returned to private ownership."
