1.8 services contracts for the provision, improvement, and development of the following
1.9 information technology systems and services to state agencies:

1.10 (1) state data centers;

1.11 (2) mainframes including system software;

1.12 (3) servers including system software;

1.13 (4) desktops including system software;

1.14 (5) laptop computers including system software;

1.15 (6) a data network including system software;

1.16 (7) database, electronic mail, office systems, reporting, and other standard software
1.17 tools;

1.18 (8) business application software and related technical support services;

1.19 (9) help desk for the components listed in clauses (1) to (8);

1.20 (10) maintenance, problem resolution, and break-fix for the components listed in clauses
1.21 (1) to (8);

2.1 (11) regular upgrades and replacement for the components listed in clauses (1) to (8);
2.2 and

2.3 (12) network-connected output devices.

2.4 (b) All state agency employees whose work primarily involves functions specified in
2.5 paragraph (a) are employees of the Office of MN.IT Services. This includes employees who
2.6 directly perform the functions in paragraph (a), as well as employees whose work primarily
2.7 involves managing, supervising, or providing administrative services or support services
2.8 to employees who directly perform these functions. The chief information officer may assign
2.9 employees of the office to perform work exclusively for another state agency.

2.10 (c) Subject to sections 16C.08 and 16C.09, the chief information officer may allow a
2.11 state agency to obtain services specified in paragraph (a) through a contract with an outside
2.12 vendor when the chief information officer and the agency head agree that a contract would
2.13 provide best value, as defined in section 16C.02, under the service-level agreement. The
2.14 chief information officer must require that agency contracts with outside vendors ensure
2.15 that systems and services are compatible with standards established by the Office of MN.IT
2.16 Services.
