#### **Bill Description**

As amended, this proposal is to provide Eventide Lutheran Home in Moorhead an operating rate increase effective January 1, 2020, and annually thereafter for each year that the median operating payment rate at a weight of 1.0 for nonprofit nursing facilities located in adjacent cites in North Dakota exceeds the equivalent for Eventide under the Minnesota Value-Based Reimbursement system.

### **Assumptions**

This proposal can be implemented within the existing administrative resources of the Department.

The effective date of the rate adjustments in this bill is January 1, 2020.

Minnesota's first fiscal year related to this bill ends on June 30, 2020.

Payment for services lags the provision of services by one month

The costs from this proposal are adjusted by forecasted changes in resident case-mix scores.

The number of annual Medicaid days will remain the same each year for this facility through FY2021.

The state share of costs/savings is determined by amounts paid by other governmental units:

- the base federal share averages 50.85% of the total; a small amount of payments are eligible for higher federal rates;
- the county share is estimated to be 2.29% of the non-federal share;
- the state share is the total minus the federal share and the county share.

At this time it is unknown what rates will be in effect in future years for North Dakota or Minnesota; current rates were used for this calculation.

# Expenditure and/or Revenue Formula

This calculation was based on the nursing facility operating rate in effect on January 1, 2017 for the rate that has a case-mix weight of 1.0. Both North Dakota and Minnesota facilities have 1.0 operating rates. The North Dakota median 1.0 operating rate of nonprofit facilities located in Fargo was used for a comparison to the 1.0 operating rate of Eventide Lutheran Home in Moorhead. The difference between these two rates was multiplied by the number of Medicaid days (based upon the 9/30/16 cost report) for each RUGs class. The increases for each RUGs class were summed to determine the total estimated cost of this proposal.

The fiscal note includes a 4% rate reduction for North Dakota for FY 2017. This reduction is due to budget issues in North Dakota state's budget. Even with this rate reduction, the North Dakota rates are still currently higher than Minnesota's

rates resulting in a cost in the fiscal note.

In the future, this calculation will be based on this facility's operating rates on November 1, 2019 and the Medicaid resident days on the 9/30/2018 cost report. In October 2018, information will need to be obtained from the North Dakota Department of Human Services to determine the equivalent operating rates of nonprofit facilities in bordering cites for rates effective January 1, 2020.
