1.4 Subd. 2. **Permanent bar to set aside a disqualification.** (a) Except as provided in
1.5 paragraph (b), the commissioner may not set aside the disqualification of any individual
1.6 disqualified pursuant to this chapter, regardless of how much time has passed, if the individual
1.7 was disqualified for a crime or conduct listed in section 245C.15, subdivision 1.

1.8 (b) For an individual ~~in the chemical dependency or corrections field~~ who was disqualified
1.9 for a crime or conduct listed under section 245C.15, subdivision 1, and ~~whose disqualification~~
1.10 ~~was set aside prior to July 1, 2005~~ more than 20 years have passed since the discharge of
1.11 the sentence imposed or, if the disqualification is not based on a conviction, more than 20
1.12 years have passed since the individual committed the act upon which the disqualification
1.13 was based, the commissioner must consider granting a set aside or variance pursuant to
1.14 section 245C.22 or 245C.30 for the license holder for a program dealing primarily with
